The City Council at a regular meeting held November 7, 2012, APPROVED the request for a request for a Special Use Permit FOR A PROPOSED 6,772 SQUARE-FOOT LIQUOR ESTABLISHMENT (TAVERN) WITH WAIVERS OF REQUIRED DISTANCE SEPARATION TO ALLOW ZERO FEET FROM A SIMILAR USE, 1,240 FEET FROM A HOUSE OF WORSHIP AND 1,340 FEET FROM A SCHOOL WHERE 1,500 FEET IS REQUIRED FROM EACH at 450 Fremont Street, Suite #135 and a portion of #140 (APN 139-34-513-002), C-2 (General Commercial) Zone. The Notice of Final Action was filed with the Las Vegas City Clerk on November 8, 2012. This approval is subject to:

Planning

1. Conformance to all Minimum Requirements under LVMC Title 19.12 for a Liquor Establishment (Tavern) use, except as modified herein.
2. This approval shall be void two years from the date of final approval, unless exercised pursuant to the provisions of LVMC Title 19.16. An Extension of Time may be filed for consideration by the City of Las Vegas.
3. A Waiver from 19.12.070 is hereby approved, to allow distance separation of zero feet from a similar use, 1,240 feet from a House of Worship and 1,340 feet from a school where 1,500 feet is required from each.
4. All necessary building permits shall be obtained and final inspections shall be completed in compliance with Title 19 and all codes as required by the Department of Building and Safety.
5. These Conditions of Approval shall be affixed to the cover sheet of any plan set submitted for building permit.
6. Approval of this Special Use Permit does not constitute approval of a liquor license.

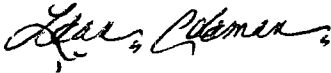

9. All City Code requirements and design standards of all City departments must be satisfied, except as modified herein.
