The City Council at a regular meeting held on July 19, 2017 voted to **APPROVE** a request for a Special Use Permit FOR A MIXED USE DEVELOPMENT at the southwest corner of Lewis Avenue and 11th Street (APN 139-34-712-098), R-4 (High Density Residential) Zone [PROPOSED C-1 (Limited Commercial)], Ward 3 (Coffin) [PRJ-69852]

This approval is subject to the following conditions

**Planning**

- 1 Conformance to all Minimum Requirements under LVMC Title 19.12 for the Mixed Use use
- 2 Approval of and conformance to the Conditions of Approval for Rezoning (ZON-70273), Variance (VAR-70275), Variance (VAR-70280), Special Use Permit (SUP-70284) and Site Development Plan Review (SDR-70285) shall be required, if approved
- 3 This approval shall be void two years from the date of final approval, unless exercised pursuant to the provisions of LVMC Title 19.16. An Extension of Time may be filed for consideration by the City of Las Vegas
- 4 All necessary building permits shall be obtained and final inspections shall be completed in compliance with Title 19 and all codes as required by the Department of Building and Safety
