Dear Applicant:

The City Council at a regular meeting held on November 1, 2017 voted to **APPROVE** a request for a Special Use Permit FOR A PROPOSED 1,819 SQUARE-FOOT MARIJUANA PRODUCTION FACILITY USE at 714 South 1st Street (APN 139-34-310-015), C-M (Commercial/Industrial) Zone, Ward 3 (Coffin) [PRJ-70877].

This approval is subject to the following conditions:

**Planning**

1. If the proposed use has two violations of the City of Las Vegas odor ordinance within one calendar year the use may be required to cease and the Special Use Permit can be revoked at a separate public hearing
2. Deliveries shall be conducted at the rear of the building
3. Conformance to all Minimum Requirements under LVMC Title 19.12 for a Marijuana Production Facility use
4. This approval shall be void 18 months from the date of final approval, unless exercised pursuant to the provisions of LVMC Title 19.16. An Extension of Time may be filed for consideration by the City of Las Vegas

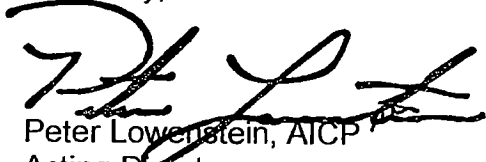

5. All necessary building permits shall be obtained and final inspections shall be completed in compliance with Title 19 and all codes as required by the Department of Building and Safety
6. These Conditions of Approval shall be affixed to the cover sheet of any plan set submitted for building permit, as well as submitted as part of any business license application.
7. All City Code requirements and design standards of all City departments must be satisfied, except as modified herein.
