The City Council at a regular meeting held on November 15 2017 voted to **APPROVE** a request for a Special Use Permit FOR A MINI-STORAGE FACILITY USE on the south side of Charleston Boulevard, approximately 160 feet west of Tenaya Way (APN 163-03-101-014), P-O (Professional Office) Zone [PROPOSED: C-1 (Limited Commercial)], Ward 1 (Tarkanian) [PRJ-71386].

This approval is subject to the following conditions


**Planning**

- 1 Conformance to all Minimum Requirements under LVMC Title 19 12 for a Mini-Storage Facility use
- 2 All signage shall be permitted and meet minimum code requirements within 30 days of final approval
- 3 Approval of and conformance to the Conditions of Approval for Variance (VAR-71405), and Site Development Plan Review (SDR-71406) shall be required, if approved
- 4 This approval shall be void two years from the date of final approval, unless exercised pursuant to the provisions of LVMC Title 19 16 An Extension of Time may be filed for consideration by the City of Las Vegas.
- 5 All necessary building permits shall be obtained and final inspections shall be completed in compliance with Title 19 and all codes as required by the Department of Building and Safety.
