Planning

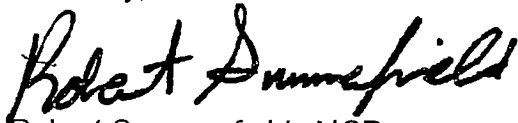
- 1 The hours of operations shall be limited to 8:00am to 1:00am
2. Conformance to all Minimum Requirements under LVMC Title 19 12 for a Restaurant with Alcohol use
- 3 This approval shall be void two years from the date of final approval, unless exercised pursuant to the provisions of LVMC Title 19 16. An Extension of Time may be filed for consideration by the City of Las Vegas.
- 4 All necessary building permits shall be obtained and final inspections shall be completed in compliance with Title 19 and all codes as required by the Department of Building and Safety
- 5 These Conditions of Approval shall be affixed to the cover sheet of any plan set submitted for building permit, as well as submitted as part of any business license application.
