Department of Planning staff has conditionally approved your request for technical review of the blue line Final Map, subject to the changes, comments and corrections noted as follows:

1. The file number "FMP-77863" shall be placed above the Recorder's block in the lower right hand corner of the cover sheet.
2. Pursuant to Condition #6 of TMP-75979, requires a technical landscape plan that shows "one, 24-inch box shade tree with four, five-gallon shrubs for each required tree shall be planted within the landscape buffer areas adjacent to Alexander Road." This landscape plan must be provided to staff before Mylar review.
3. Pursuant to Condition #9 of TMP-75979, "A Petition of Vacation, such as VAC-75978, shall record immediately prior to (concurrent with) the recordation of a Final Map for this site to eliminate the U.S Government Patent Easements adjacent to this site."
4. The Original Final Map mylar shall be in conformance with all applicable conditions of approval for the approved Tentative Map of Alexander Juliano West(TMP-75979).
5. Revise the signature block of the Department of Planning certificate to read:

We note that the required Drainage Plan and Technical Drainage Study on file with the Flood Control Section of the Department of Public Works is not yet approved and is awaiting concurrence from Clark County Regional Flood Control District and Clark County Public Works.

**CONDITIONS OF APPROVAL:**

1. Per condition of approval #11 of TMP-75979 a Petition of Vacation, such as VAC-75978, shall record prior to (concurrent with) this Final Map to eliminate the U.S. Government Patent Easements.
2. On sheet 1, remove all references to "Sewer" and "Public Sewer Easements" from the LVVWD Note.
3. On sheet 3, replace Easement "C" with Easement "D" (Public Sewer and Public Drainage Easements). Replace language "Existing Sewer Easement Per OR:20001003:00684" with "Declaration Of Utilization For Sewer Purposes Per OR:20001003:00684."
4. On sheet 3, revise Note "P" in the Legend to read "Private Street, Public Sewer Easement, City of Las Vegas Public Drainage Easement and utility easement to be Privately Maintained by the Homeowner's Association."
5. The submitted Drainage Plan and Technical Drainage Study shall be approved prior to recordation of this Final Map. Public Drainage Easements granted on this map shall match the approved drawings for this site.
6. Include the Final Map number, FMP-77863, above the Recorder's Block on the cover sheet.
7. Dimensions and information presented on the approved civil improvement plans shall match the Final Map prior to recordation. Revise approved civil plans if necessary.
8. Site development to comply with all previous conditions of approval for the Alexander Juliano West Tentative Map (TMP 75979) and all other site-related actions.
