Dear Mr. Stewart:

Your request for a Special Use Permit FOR A THRIFTSHP, NONPROFIT at 4580 West Sahara Avenue, Suite #120 (APN 162-06-411-004), C-1 (Limited Commercial) Zone, Ward 1 (Tarkanian), was considered by the Planning Commission on August 14, 2012.

The Planning Commission voted to **APPROVE** your request, subject to the following:

Planning

1. Conformance to all Minimum Requirements under LVMC Title 19.12 for a Thriftshop, Nonprofit use.
2. This approval shall be void two years from the date of final approval, unless exercised pursuant to the provisions of LVMC Title 19.16. An Extension of Time may be filed for consideration by the City of Las Vegas.
3. All necessary building permits shall be obtained and final inspections shall be completed in compliance with Title 19 and all codes as required by the Department of Building and Safety.
4. These Conditions of Approval shall be affixed to the cover sheet of any plan set submitted for building permit.
5. All deliveries, donations, loading, and unloading at the premises shall be completed during normal business hours.
6. All City Code requirements and design standards of all City departments must be satisfied, except as modified herein.
