PLANNING COMMISSION MEETING OF OCTOBER 13, 2015**

Dear Applicant:

Your request for a Special Use Permit FOR AN EXISTING OPEN AIR VENDING (TACO CART) ADJACENT TO RESIDENTIALLY ZONED PROPERTY TO HAVE PROPOSED HOURS OF OPERATION FROM 8:00 AM TO MIDNIGHT, WHERE 10:00 AM TO 8:00 PM IS ALLOWED at 4949 East Bonanza Road (APN 140-29-801-010), C-1 (Limited Commercial) Zone, Ward 3 (Coffin) [PRJ-60265], was considered by the Planning Commission on October 13, 2015.

The Planning Commission voted to **APPROVE** your request, subject to the following:

Planning

1. Conformance to all Minimum Requirements under LVMC Title 19.12 for an Open Air Vending use.
2. This approval shall be void two years from the date of final approval, unless exercised pursuant to the provisions of LVMC Title 19.16. An Extension of Time may be filed for consideration by the City of Las Vegas.
3. A Waiver from Title 19.12 is hereby approved, for an Open Air Vending (taco cart) adjacent to residentially zoned property with proposed hours of operation from 8:00am to midnight, where 10:00am to 8:00pm is allowed.
4. All necessary building permits shall be obtained and final inspections shall be completed in compliance with Title 19 and all codes as required by the Department of Building and Safety.
5. These Conditions of Approval shall be affixed to the cover sheet of any plan set submitted for building permit, as well as submitted as part of any business license application.
6. All City Code requirements and design standards of all City departments must be satisfied, except as modified herein.


