Dear Mr. Chappell:

Your request for possible action on a request for a Variance TO ALLOW 10 PROPOSED FREESTANDING SIGNS TO BE SPACED 35 FEET APART WHERE SIX SIGNS SPACED AT LEAST 100 FEET APART ARE ALLOWED on 28.43 acres at the northeast corner of Alta Drive and Rampart Boulevard (APN 138-32-615-001), C-2 (General Commercial) Zone, Ward 2 (Beers), was considered by the Planning Commission on November 12, 2013.

The Planning Commission voted to **APPROVE** your request, subject to the following:

Planning

1. Approval of this application shall be for a maximum of six signs equally spaced along the Rampart Boulevard street frontage.
2. Approval of and conformance to the Conditions of Approval for a Major Amendment (MSP-50954) of an approved Master Sign Plan (MSP-40230) shall be required, if approved.
3. This approval shall be void two years from the date of final approval, unless exercised pursuant to the provisions of LVMC Title 19.16. An Extension of Time may be filed for consideration by the City of Las Vegas.
4. All necessary building permits shall be obtained and final inspections shall be completed in compliance with Title 19 and all codes as required by the Department of Building and Safety.
5. These Conditions of Approval shall be affixed to the cover sheet of any plan set submitted for building permit.
6. All City Code requirements and design standards of all City departments must be satisfied, except as modified herein.

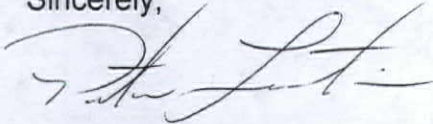
