Please be sure to include the relevant bill or item number in your comments. E-mails received up to an hour before the meeting will be considered public record, read during the item and included in the backup. E-mails must contain the meeting name, date and item number in the subject. A time limit may be imposed on the comments read for the record.

The Recommending Committee will receive public input on each item of legislation being considered. The Recommending Committee may, thereafter, continue the hearing to a future date or formulate a recommendation to the City Council for passage, rejection or amendment of the proposed bill. Any member of the City Council may substitute for a member of the Recommending Committee at any time.

Items listed on the agenda may be taken out of the order presented; two or more agenda items for consideration may be combined; and any item on the agenda may be removed or related discussion may be delayed at any time. 2. Announcement Regarding: Compliance with Open Meeting Law
3. Bill No. 2020-20 - For possible action - Authorizes, on a temporary basis, a partial waiver of the origination charge for new restaurant service bar licenses. Sponsored by: Councilwoman Victoria Seaman
4. Bill No. 2020-21 - For possible action - Amends various provisions of the Unified Development Code to establish the circumstances under which on-premise signs with off-premise messaging are permitted in connection with certain non-restricted gaming establishments, commercial recreation/amusement establishments (indoor or outdoor), and convention facilities. Proposed by: Scott D. Adams, City Manager
5. Citizens Participation: Public comment during this portion of the agenda must be limited to matters within the jurisdiction of the Committee. No subject may be acted upon by the Committee unless that subject is on the agenda and is scheduled for action. The amount of discussion on any single subject, as well as the amount of time any single speaker is allowed, may be limited.
