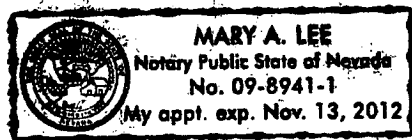

Friday and Saturday, January 13 and 14 9:00 a.m. - 9:00 p.m.
