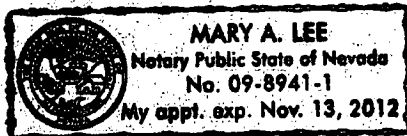

In compliance with Nevada Revised Statutes (NRS), Chapters 306 and 293C and the Nevada Administrative Code (NAC) Chapter 306, I, Beverly K. Bridges, City Clerk and Filing Officer for the City of Las Vegas, Nevada, do hereby publicly announce and Call for a Special Election to be conducted on **Tuesday, January 31, 2012, from 7:00 a.m. to 7:00 p.m.** for the purpose of recall of Steven D. Ross as City Councilman, Ward 6. The final results of said election will be canvassed at a Special City Council Meeting to be held on **Monday, February 6, 2012.**

Close of Voter Registration: The last day on which a person, living within the Ward 6 boundaries of the City of Las Vegas, may register to vote to qualify for the Special Election shall be **Saturday, January 14, 2012 at 9:00 p.m.** The City Clerk's Office is located at Las Vegas City Hall, 400 Stewart Avenue, First Floor, Las Vegas, Nevada and will be open for extended hours prior to the close of registration as follows:

Thursday, January 12	7:00 a.m. to 9:00 p.m.
Friday, January 13	9:00 a.m. to 9:00 p.m.
Saturday, January 14	9:00 a.m. to 9:00 p.m.

Residency: The last day on which a candidate could have become a resident of Ward 6 was **Monday, December 12, 2011.**

Petition to Nominate: The last day on which a petition will be accepted to nominate a candidate for the office of Councilman, Ward 6, shall be set for **Wednesday, January 11, 2012 at 5:00 p.m.** All petitions must be filed with the City Clerk/Filing Officer for the City of Las Vegas in the Office of the City Clerk, Las Vegas City Hall, 400 Stewart Avenue, First Floor.

Acceptance of Candidacy: In addition, all acceptance of candidacy forms and filing fees (\$100.00) must be completed and paid by a candidate on **Wednesday, January 11, 2012 by 5:00 p.m.**

Withdrawal of Candidacy: The last day on which a candidate may withdraw his or her candidacy shall be set for **Thursday, January 12, 2012 at 5:00 p.m.** with the City Clerk/Filing Officer in the Office of the City Clerk at 400 Stewart Avenue, First Floor, Las Vegas, Nevada.

Request for Absent Ballot: The last day to request an absent ballot shall be set for **Tuesday, January 24, 2012 at 5:00 p.m.** in the office of the City Clerk at 400 Stewart Avenue, First Floor, Las Vegas, Nevada or the office of the Clark County Election Department at 965 Trade Drive, Suite A, North Las Vegas, Nevada 89030-7802.
