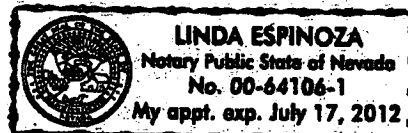

NOTICE OF EARLY VOTING FOR THE CITY OF LAS VEGAS 2012 SPECIAL RECALL ELECTION

NOTICE IS HEREBY GIVEN that early voting for the January 31, 2012 Special Recall Election will take place in the city of Las Vegas Ward 6.

RESIDENCY REQUIREMENT

Only those voters who are registered to vote in the city of Las Vegas Ward 6 are eligible to vote in this election. You cannot vote in this Special Recall Election if you are registered to vote in any Ward other than Ward 6 or in the unincorporated areas of Clark County.

VOTING BY MAIL

Any registered voter who is eligible to vote in Las Vegas Ward 6 may choose to vote by mail. A written request for a mail ballot must be received by 5 p.m. on January 24, 2012. Mail ballot requests may be obtained from the Las Vegas City Clerk's Office, 400 Stewart Avenue, Las Vegas, Nevada 89101 or the Clark County Election Department, 965 Trade Drive, Suite A, North Las Vegas, Nevada 89030-7802.

VOTING IS EASY! Las Vegas Ward 6 voters may vote at any of the convenient early voting sites OR on Election Day at one of the Voting Centers. If you received a ballot by mail, you may surrender that ballot at any Early Vote location and vote.
