16 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
17 ORDAIN AS FOLLOWS:

18 SECTION 1: Title 6, Chapter 42, of the Municipal Code
19 of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended
20 by adding thereto the provisions that are set forth as Section 2
21 of this Ordinance.

22 SECTION 2: (A) No person shall deposit, fasten, throw,
23 scatter, cast or place any commercial or noncommercial handbill:

24 (1) In or upon any vehicle that is parked on any
25 public street or on any property that is owned by the City; or

26 (2) In or upon any vehicle parked in or upon any
27 private property that provides multiple spaces for parking
28 vehicles. Such property shall without limitation include such
29 locations as parking garages, shopping centers, shopping malls,
30 outdoor theaters, drive-in restaurants, gasoline service sta-
31 tions, apartment and housing developments and complexes, casino
and other types of parking lots and any other place where provi-
sion is made for vehicles to stop or park in designated areas for
any purpose.

1 (B) The provisions of subsections sections (1) and (2)
2 shall not be deemed to prohibit in any public or private place
3 the distribution of any commercial or noncommercial handbill by
4 hand delivery to the owner or other occupant of any vehicle who
5 is willing to accept the handbill without payment therefor.

6 SECTION 3: If any section, subsection, subdivision,
7 paragraph, sentence, clause or phrase in this ordinance or any
8 part thereof is for any reason held to be unconstitutional or
9 invalid or ineffective by any court of competent jurisdiction,
10 such decision shall not affect the validity or effectiveness of
11 the remaining portions of this ordinance or any part thereof.
12 The City Council of the City of Las Vegas, Nevada, hereby
13 declares that it would have passed each section, subsection, sub-
14 division, paragraph, sentence, clause or phrase thereof
15 irrespective of the fact that any one or more sections, subsec-
16 tions, subdivisions, paragraphs, sentences, clauses, or phrases
17 be declared unconstitutional, invalid or ineffective.

18 SECTION 4: Whenever in this ordinance any act is prohi-
19 bited or is made or declared to be unlawful or an offense or a
20 misdemeanor, or whenever in this ordinance the doing of any act
21 is required or the failure to do any act is made or declared to
22 be unlawful or an offense or a misdemeanor, the doing of such
23 prohibited act or the failure to do any such required act shall
24 constitute a misdemeanor and upon conviction thereof, shall be
25 punished by a fine of not more than \$1,000.00 or by imprisonment
26 for a term of not more than six months, or by any combination of
27 such fine and imprisonment. Any day of any violation of this
28 ordinance shall constitute a separate offense.

29 SECTION 5: All ordinances or parts of ordinances, sec-
30 tions, subsections, phrases, sentences, clauses or paragraphs


