13 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY  
14 ORDAIN AS FOLLOWS:

15 SECTION 1: The Master Plan of Streets and Highways  
16 provided for in Title 13, Chapter 12, Section 30, of the Muni-  
17 cipal Code of the City of Las Vegas, Nevada, 1983 Edition, is  
18 hereby amended by deleting therefrom the following:

19 (A) Peccole Strada, east of Fort Apache Road and north  
20 of Sahara Avenue.

21 (B) Oakey Boulevard, between Peccole Strada and Durango  
22 Drive.

23 Said deletions are generally illustrated in Exhibit "A", which is  
24 attached hereto and incorporated herein by reference.

25 SECTION 2: If any section, subsection, subdivision,  
26 paragraph, sentence, clause or phrase in this ordinance or any  
27 part thereof, is for any reason held to be unconstitutional or  
28 invalid or ineffective by any court of competent jurisdiction,  
29 such decision shall not affect the validity or effectiveness of  
30 the remaining portions of this ordinance or any part thereof.  
31 The City Council of the City of Las Vegas, Nevada, hereby  
32 declares that it would have passed each section, subsection, sub-  
division, paragraph, sentence, clause or phrase thereof irrespec-

1 tive of the fact that any one or more sections, subsections, sub-  
2 divisions, paragraphs, sentences, clauses or phrases be declared  
3 unconstitutional, invalid or ineffective.

4 SECTION 3: All ordinances or parts of ordinances, sec-  
5 tions, subsections, phrases, sentences, clauses or paragraphs  
6 contained in the Municipal Code of the City of Las Vegas, Nevada,  
7 1983 Edition, in conflict herewith are hereby repealed.

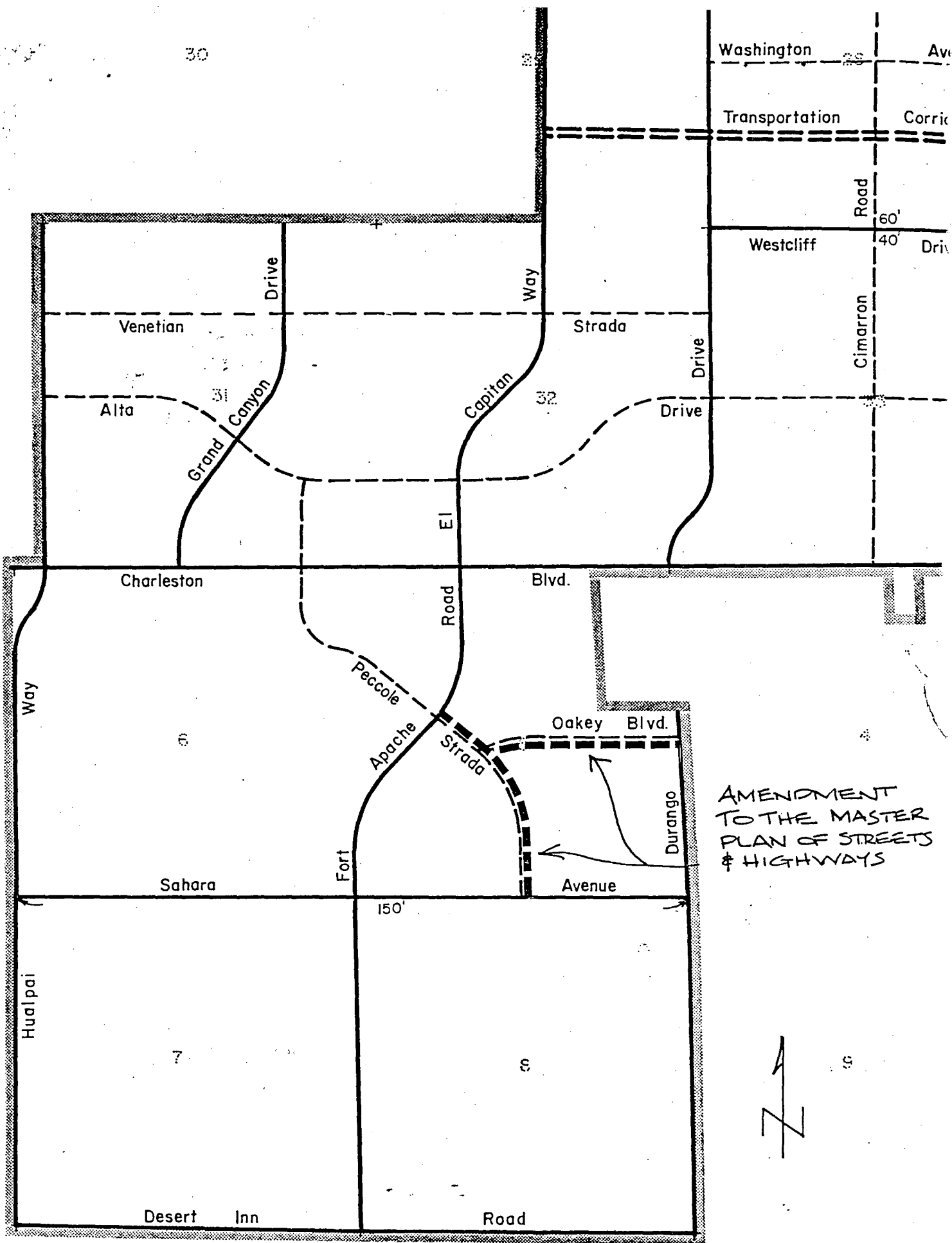
