FIRST AMENDMENT
BILL NO. 97-65

AN ORDINANCE RELATING TO THE COLLECTION OF GARBAGE AND RECYCLABLE MATERIALS; AMENDING TITLE 9, CHAPTER 8, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY ADDING THERETO A NEW SECTION, DESIGNATED AS SECTION 105, TO LIMIT THE HOURS DURING WHICH GARBAGE, RUBBISH AND RECYCLABLE MATERIALS MAY BE COLLECTED; AMENDING CHAPTER 16 OF SAID TITLE BY ADDING THERETO A NEW SECTION, DESIGNATED AS SECTION 35, AND BY AMENDING SECTION 40 OF SAID CHAPTER, TO MAKE PARALLEL CHANGES IN THE CITY'S NOISE DISTURBANCE REGULATIONS; PROVIDING PENALTIES FOR THE VIOLATION THEREOF; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.
