BILL NO. 86-6  
AN ORDINANCE RELATING TO THE REGULATION OF COMMUNITY ANTENNA TELEVISION COMPANIES; AMENDING TITLE 6, CHAPTER 20, SECTION 10, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, TO REVISE VARIOUS DEFINITIONS; AMENDING SECTION 20 OF SAID TITLE AND CHAPTER TO CLARIFY WHICH BUSINESSES REQUIRE A FRANCHISE; AMENDING SECTION 40 OF SAID TITLE AND CHAPTER TO REQUIRE ADDITIONAL INFORMATION BE PROVIDED IN THE APPLICATION FOR A FRANCHISE AND TO DELETE THE FILING OF PROPOSED RATES AND CHARGES; AMENDING SECTION 130 OF SAID TITLE AND CHAPTER TO DELETE OUTDATED REFERENCES TO THE PUBLIC SERVICE COMMISSION; AMENDING SECTION 140 OF SAID TITLE AND CHAPTER TO PROVIDE FOR A REFERENCE BUSINESS LICENSE FEE AND A FRANCHISE FEE FOR A FRANCHISEE AND TO REMOVE THE THREE PERCENT (3%) CEILING ON THE AMOUNT OF THE FRANCHISE FEE; AMENDING SECTIONS 110 AND 310 AND ADDING A NEW SECTION TO SAID TITLE AND CHAPTER, DESIGNATED AS SECTION 460, WHICH IMPOSES CERTAIN STANDARDS AND REQUIREMENTS WITH RESPECT TO THE INSTALLATION OF CATV FACILITIES IN, UNDER, UPON OR OVER THE PUBLIC RIGHTS-OF-WAY OR PUBLIC EASEMENTS LOCATED IN RESIDENTIAL YARDS; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

SUMMARY: Makes various amendments to the regulations which are contained in the Las Vegas City Code and relate to the operation of Community Antenna Television Companies.
