AN ORDINANCE RELATING TO THE REGULATION OF NEWS RACKS ON PUBLIC RIGHTS-OF-WAY; AMENDING VARIOUS PROVISIONS OF TITLE 13 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, TO PROVIDE FOR THE DEFINITIONS OF PUBLIC RIGHT-OF-WAY, AND PLANNING DIRECTOR; TO PROVIDE FOR REGISTRATION OF LOCATION WITH THE PLANNING DIRECTOR; TO PLACE THE REGULATION OF NEWS RACKS UNDER THE DIRECTION OF THE PLANNING DIRECTOR; TO PROHIBIT NEWS RACKS INSTALLED AT ANY LOCATION WHEREBY THE CLEAR SPACE FOR PASSAGEWAY OF PEDESTRIANS IS REDUCED TO LESS THAN SIX FEET OR WITHIN THREE FEET OF ANY AREA IMPROVED WITH LAWN, FLOWERS, SHRUBS OR TREES; ESTABLISHING CRITERIA OF PRIORITIES WHENEVER MORE THAN EIGHT NEWS RACKS ARE PROPOSED FOR ANY ONE LOCATION (TWO HUNDRED FOOT SPACE) OR MORE THAN SIXTEEN NEWS RACKS ARE PROPOSED FOR ANY ONE BLOCK; TO PROVIDE FOR THE IMPOUNDMENT OF NEWS RACKS FOR NON-COMPLIANCE WITH THIS CHAPTER; TO REQUIRE ALL NEWS RACKS TO BE BROUGHT INTO COMPLIANCE WITH THESE PROVISIONS WITHIN SIXTY DAYS OF THE EFFECTIVE DATE; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

SUMMARY: Provides the Planning Director with regulation authority of news racks, establishes a criteria of priorities for the location of news racks, and makes other changes relating to the impoundment of news racks on public rights-of-way.
