BILL NO. 93-16

AN ORDINANCE RELATING TO CITY WARD ADVISORY BOARDS; AMENDING TITLE 2 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY ADDING THERETO A NEW CHAPTER PROVIDING FOR THE CREATION OF ADVISORY BOARDS FOR EACH OF THE FOUR CITY WARDS; PROVIDING FOR THE APPOINTMENT OF MEMBERS TO THE BOARDS; PROVIDING FOR OFFICERS OF THE BOARDS; PROVIDING FOR THE DUTIES AND RESPONSIBILITIES OF THE BOARDS; PROVIDING FOR THE RULES AND PROCEDURES FOR GOVERNING THE AFFAIRS OF THE BOARDS; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HERewith.

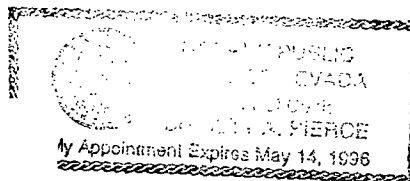
