 AN ORDINANCE RELATING TO LIQUOR CONTROL; AMENDING TITLE 4, CHAPTER 50, SECTION 50.01 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION; BY ALLOWING THE CITY COUNCIL TO WAIVE THE REQUIREMENT THAT RESTAURANTS HAVE A FORTY-FIVE SEATING CAPACITY AS A CONDITION OF BEING ISSUED A BEER WINE COOLER ON-SALE LIQUOR LICENSE; BY PROHIBITING ISSUANCE OF A GAMING LICENSE IN CONJUNCTION WITH A BEER WINE COOLER LIQUOR LICENSE TO RESTAURANTS WITH FEWER THAN FORTY-FIVE SEATS; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERE TO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

 SUMMARY: Permits issuance of a beer/wine cooler on-sale liquor license to restaurants with fewer than forty-five but not less than thirty seats, provided it is not issued in conjunction with a gaming license of said location.
