 AN ORDINANCE RELATING TO CHARITABLE SOLICITATIONS; REPEALING CHAPTER 22 OF TITLE 6 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, AND AMENDING SAID TITLE BY ADOPTING A NEW CHAPTER DESIGNATED AS CHAPTER 22; PROVIDING FOR CERTAIN DEFINITIONS, CHARITABLE PERMIT APPLICATION REQUIREMENTS, CHARITABLE PROMOTER LICENSES, CHARITABLE PROMOTER LICENSE APPLICATION REQUIREMENTS, THE EXEMPTION OF CHARITABLE PROMOTERS FROM THE PROVISIONS OF CERTAIN SECTIONS AND SUBSECTIONS OF CHAPTER 2 OF SAID TITLE, LICENSE FEES FOR CHARITABLE PROMOTERS; AND AMENDING CHAPTER 4 OF SAID TITLE BY ADDING THERETO A NEW BUSINESS LICENSE CATEGORY KNOWN AS "CHARITABLE PROMOTER"; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCE IN CONFLICT HEREWITH.
