AN ORDINANCE RELATING TO BUSINESS LICENSING LAWS; AMENDING TITLE 6, CHAPTER 19 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, 1983 EDITION, BY ADDING THERETO A NEW SECTION, DESIGNATED AS SECTION 55, REQUIRING THAT OPERATORS OF ALL CARNIVAL RIDES AND GAMES ADMIT PATRONS ONLY ON PRESENTATION OF TICKETS OR COUPONS PURCHASED IN ADVANCE AT ON-SITE TICKET BOOTHS; PROVIDING FOR OTHER MATTERS RELATED THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Requires that operators of carnival games and rides admit patrons only on presentation of prepaid tickets purchased at on-site ticket booths.
