AN ORDINANCE RELATING TO ON-PREMISES SIGNS; AMENDING TITLE 17, CHAPTER 58, SECTION 110, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, TO LIMIT THE HEIGHT OF ON-PREMISES SIGNS IN THE C-1 ZONING DISTRICT TO THIRTY-FIVE FEET; AMENDING SECTION 230 OF SAID TITLE AND CHAPTER TO LIMIT THE HEIGHT OF ON-PREMISES SIGNS IN C-2, C-M AND M ZONING DISTRICTS TO FIFTY FEET; AMENDING SECTION 320 OF SAID TITLE AND CHAPTER TO ALLOW FOR A WAIVER OF HEIGHT AND CERTAIN OTHER SIGN REQUIREMENTS WITH RESPECT TO PROPERTY UPON WHICH NONRESTRICTED GAMING IS PERMITTED; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Establishes maximum heights for on-premises signs in commercial and industrial zoning districts.
