AN ORDINANCE CONCERNING CITY OF LAS VEGAS, NEVADA, SPECIAL IMPROVEMENT DISTRICT NO. 412 (WASHINGTON AVENUE); AUTHORIZING THE ISSUANCE OF REGISTERED SPECIAL ASSESSMENT LOCAL IMPROVEMENT BONDS, SERIES SEPTEMBER 1, 1992, FOR CITY OF LAS VEGAS, NEVADA, SPECIAL IMPROVEMENT DISTRICT NO. 412 (WASHINGTON AVENUE) IN THE PRINCIPAL AMOUNT OF \$- TO FINANCE THE CONSTRUCTION AND INSTALLATION OF CERTAIN LOCAL IMPROVEMENTS; ACCEPTING A BID FOR THE PURCHASE OF SUCH BONDS; APPROVING, RATIFYING AND CONFIRMING ALL ACTION PREVIOUSLY TAKEN; PROVIDING FOR THE ISSUANCE AND SALE OF FULLY REGISTERED BONDS IN VARIOUS DENOMINATIONS; PRESCRIBING THE FORM OF SAID BONDS; PROVIDING THE SOURCE OF PAYMENT, AND OTHER DETAILS IN CONNECTION THEREWITH AND OTHER MATTERS RELATING THERETO; AND PROVIDING THAT SAID ORDINANCE SHALL BECOME EFFECTIVE THE DAY FOLLOWING THE PUBLICATION THEREOF, BY TITLE ONLY, IN A NEWSPAPER PUBLISHED AND OF GENERAL CIRCULATION WITHIN SAID CITY.
