Summary: Adopts the Safety and Seismic
Safety Element of the Las Vegas 2020 Master
Plan.

7 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
8 AS FOLLOWS:

9 SECTION 1: The document entitled "Safety and Seismic Safety Element," the
10 essential contents of which were approved by the City Council on May 19, 2010, is hereby adopted
11 as a part of the Las Vegas 2020 Master Plan and is incorporated therein by this reference. The
12 document so identified shall function as the safety element and the seismic safety element of the Las
13 Vegas 2020 Master Plan, and shall replace and supersede the Public Safety Element that was adopted
14 on September 19, 2001, by means of Ordinance No. 5362.

15 SECTION 2: The Planning and Development Department is authorized and direct to:

16 (A) Include the date of the adoption of this Ordinance within or upon the document
17 referred to in Section 1 at such locations as are designed to reflect the date of the adoption of this
18 Ordinance;

19 (B) Replace any page within the document that may indicate it is in "draft" form
20 with a final version of that page;

21 (C) Publish the document in final form, in a format deemed necessary or
22 appropriate, including the reorganization of text and maps as may be appropriate; and


23 (D) File the final document with the City Clerk.


24 SECTION 3: If any section, subsection, subdivision, paragraph, sentence, clause or
25 phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or
26 ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
27 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
28 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,


1 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
2 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
3 invalid or ineffective.

4 SECTION 4: All ordinances or parts of ordinances or sections, subsections, phrases,
5 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,
6 1983 Edition, in conflict herewith are hereby repealed.

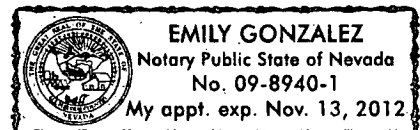
