AN ORDINANCE RELATING TO GAMING CONTROL; MAKING CERTAIN LEGISLATIVE DETERMINATIONS; AMENDING TITLE 6, CHAPTER 40, SECTION 20, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, TO PROVIDE DEFINITIONS FOR THE TERMS "BOWLING ALLEY" AND "LOCATION", AS SUCH TERMS ARE USED IN SAID TITLE AND CHAPTER; AMENDING SECTION 150 OF SAID TITLE AND CHAPTER TO AUTHORIZE THE ISSUANCE OF NONRESTRICTED GAMING LICENSES TO BOWLING ALLEYS FOR THE OPERATION OF SLOT MACHINES ONLY IN A NUMBER THAT IS BASED UPON THE NUMBER OF BOWLING LANES IN THE PARTICULAR BOWLING ALLEY; PROVIDING FOR OTHER MATTERS THAT PROPERLY RELATE THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.
