

ORDINANCE NO. 803

AN ORDINANCE TO AMEND SECTION 6 OF ORDINANCE NO. 388 ENTITLED: "AN ORDINANCE REGULATING THE RETAIL SALE OF CIGARETTE PAPERS, CIGARETTES, CIGARS, TOBACCO IN ANY FORM, AND TOBACCO PRODUCTS; PROVIDING FOR THE LICENSING OF PERSONS SELLING AT RETAIL ANY CIGARETTE PAPERS, CIGARETTES, CIGARS, TOBACCO IN ANY FORM OR TOBACCO PRODUCTS; PROVIDING A PENALTY FOR THE VIOLATION THEREOF, AND OTHER MATTERS PROPERLY RELATING THERETO," BY FURTHER PROVIDING FOR THE LICENSING OF FIRMS, PARTNERSHIPS AND CORPORATIONS SELLING AT RETAIL ANY CIGARETTE PAPERS, CIGARETTES, CIGARS, TOBACCO IN ANY FORM OR TOBACCO PRODUCTS; PROVIDING A PENALTY FOR THE VIOLATION THEREOF, AND OTHER MATTERS PROPERLY RELATED THERETO.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DO ORDAIN AS FOLLOWS:

SECTION 1. Section 6 of Ordinance No. 388 is hereby amended to read as follows:

SECTION 6. APPLICATION FOR LICENSE. All applications for license under the provisions of this ordinance shall be made in writing to the Mayor and City Commissioners and filed with the City Clerk on a form provided for that purpose.

Every application shall contain the name of the person desiring the license and the place of business sought to be licensed. If the applicant is a partnership or firm, the application shall contain the names and residence address of all persons holding any interest in said partnership or firm; if a corporation, the application shall contain the names and residences of each stockholder and officer thereof and the managing agent or managing director not appearing on the license, each of whom shall be investigated and the fee for such investigation shall be Fifty (\$50.00) Dollars for each person investigated.

SECTION 2. PENALTY. Any person violating any of the provisions of this section shall be guilty of a misdemeanor.

SECTION 3. EFFECT OF INVALIDITY. If any part, provision or section of this ordinance or the application thereof to any person or circumstance shall be held to be invalid by any court of competent jurisdiction, the remainder of this ordinance or the application of such part, provision or section thereof to any other person or circumstances shall not be affected thereby.

SECTION 4. EFFECTIVE DATE. This ordinance shall be in full force and effect upon its publication as in the next section provided, and final passage.

SECTION 5. PUBLICATION. The Acting City Clerk and Clerk of the Board of Commissioners of the City of Las Vegas shall cause this ordinance to be published once a week for two successive weeks immediately following its first reading and adoption, in the Las Vegas , a daily newspaper published in the City of Las Vegas.
