

ORDINANCE NO. 1491

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 22, SUBSECTION D, PARAGRAPH 6 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, TO ASSIMILATE THE ZONING REGULATIONS WITH THE FIRE ZONE ORDINANCE; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES OR PARTS ~~OR~~ <sup>OF</sup> ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Title XI, Chapter 1, Section 22, Subsection D, Paragraph 6 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

11-1-22 (D) 6. Fire Hazards: All property included within an industrial district shall be considered in Fire Zone No. 2 and meet all requirements and regulations of said Fire Zone, as administered by the Fire Prevention Bureau.

SECTION 2. Any person, firm or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the city jail for not more than six (6) months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.


SECTION 3. All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.



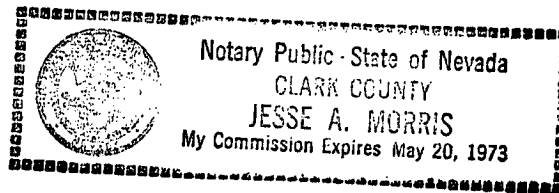


