

ORDINANCE NO. 1423

AN ORDINANCE TO AMEND TITLE X OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION; TO AMEND CHAPTER 14, SECTION 3, SUBSECTION (B), TO REVISE SCHEDULE V THEREOF PROVIDING FOR STOP STREETS; TO AMEND CHAPTER 17, SECTION 24 OF SAID TITLE TO REVISE SCHEDULE VII THEREOF PROHIBITING PARKING AT ALL TIMES ON CERTAIN STREETS; TO AMEND CHAPTER 17, SECTION 26 OF SAID TITLE TO REVISE SCHEDULE IX THEREOF PROHIBITING STOPPING, STANDING OR PARKING ON CERTAIN STREETS DURING CERTAIN HOURS; TO AMEND CHAPTER 17, SECTION 27 OF SAID TITLE TO REVISE SCHEDULE X THEREOF LIMITING PARKING TIME ON CERTAIN STREETS; TO AMEND CHAPTER 25, SECTION 2(C) OF SAID TITLE TO REVISE SCHEDULE I THEREOF PROVIDING 30 AND 35 MILES PER HOUR SPEED LIMITS ON CERTAIN STREETS; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Title X, Chapter 14, Section 3, Subsection (B) of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended by adding to Schedule V thereof the following:

10-14-3(B): SCHEDULE V

Hassett Avenue at Bruce Street
Howard Avenue at Bruce Street
Canosa Avenue at Bruce Street
Bonita Avenue at Bruce Street
Canosa Avenue at Atlantic Street
Las Vegas Expressway at Torrey Pines Drive

SECTION 2. Title X, Chapter 17, Section 24 of said Municipal Code is hereby amended by adding to Schedule VII thereof the following:

10-17-24: SCHEDULE VII

Charleston Boulevard - along both sides from Rancho Road
to Decatur Boulevard
Bonanza Road - along the south side from 7th Street to
16th Street
Paradise Road - along the west side from Sahara Avenue
to St. Louis Avenue
Evergreen Avenue - along the south side from Decatur Boulevard
west a distance of 1000 feet

SECTION 3. Title X, Chapter 17, Section 26 of said Municipal Code is hereby amended by adding to Schedule IX thereof the following:

10-17-26: SCHEDULE IX

Eastern Avenue - along the east side from Ballard Drive to
Oakey Boulevard (Monday through Friday,
7:00 A.M. to 9:00 A.M.)

SECTION 4. Title X, Chapter 17, Section 27 of said Municipal Code is hereby amended by adding to Schedule X thereof the following:

10-17-27:

SECTION 5. Schedule I of Title X, Chapter 25, Section 2, Subsection (C) of said Municipal Code is hereby amended to read as follows:

10-25-2(C):

SCHEDULE I

In accordance with Section 2(C), and when properly signposted, the speed limit shall be thirty miles per hour (30 mph) upon the following streets or portions thereof:

Main Street - between Owens Avenue and Las Vegas Boulevard South.

Las Vegas Boulevard South - between Bonanza Road and Sahara Avenue.

Bonneville Avenue - between Main Street and Maryland Parkway.

Fourth Street - between Stewart Avenue and Las Vegas Boulevard South.

Casino Center Boulevard - between Bonanza Road and Oakey Boulevard.

The speed limit shall be thirty-five miles per hour (35 mph) upon the following streets or highways or portions thereof:

Sahara Avenue - from Maryland Parkway to the westerly city limits.

Fremont Street - commonly known as Boulder Highway, beginning at 13th Street east to the easterly city limits.

Charleston Boulevard - for its entire length in the city.

Bonanza Road - between Tonopah Highway and 28th Street.

Rancho Road - between Charleston Boulevard and Bonanza Road.

Rancho Drive - between Charleston Boulevard and Sahara Avenue.

North 25th Street - between Charleston Boulevard and Owens Avenue.

Tonopah Highway - between Bonanza Road and Lake Mead Boulevard.

Highland Drive - between Lake Mead Boulevard and West Charleston.

Highland Drive - between Sahara Avenue and southerly city limits.

Oakey Boulevard - between Highland Drive and Valley View.
Vegas Drive-Owens Avenue - between Cherokee Lane and "H" Street.
Vegas Drive - between Tonopah Highway and Decatur Boulevard.
Las Vegas Boulevard North - between Bonanza Road and Owens Avenue.
Industrial Road - between Wyoming Avenue and Sahara Avenue.
Wyoming Avenue-Oakey Boulevard - between Main Street and Valley View; between Arville and Decatur Boulevard.
Smoke Ranch Road - between Decatur Boulevard and Tonopah Highway.
Decatur Boulevard - between Sahara Avenue and Tonopah Highway.
West Fremont - Decatur Boulevard to westerly city limits.
Washington Avenue - Tonopah Highway to Highland Drive.
Alta Drive - Rancho Road to Highland Drive.
Mojave Road - between Bonanza Road and Washington Avenue.
Highland Drive - between Charleston Boulevard and Oakey Boulevard.
Oakey Boulevard - between Valley View Drive and Arville Street.
Western Street - between Highland Drive and Charleston Boulevard.

The speed limit shall be forty-five miles per hour (45 mph) upon the following streets or highways or portions thereof:

Bonanza Road - between 28th Street and Nellis Boulevard.
Tonopah Highway - between Vegas Drive and Decatur Boulevard.
Smoke Ranch Road - between Tonopah Highway and Clayton.
West Fremont - between Rancho Road and Decatur Boulevard.
Sahara Avenue - between Maryland Parkway and Boulder Highway.
Mojave Road - from Bonanza Road to Charleston Boulevard.
Lamb Boulevard - from Charleston Boulevard to Owens Avenue.

The speed limit shall be fifty-five miles per hour (55 mph) upon the following streets or highways or portions thereof:

Tonopah Highway - between Decatur Boulevard and Cheyenne Road.

The speed limit shall be sixty-five miles per hour (65 mph) upon the following streets or highways or portions thereof:

Tonopah Highway - between Cheyenne Road and northerly city limits.


SECTION 6. Any person, firm or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the city jail for not more than six months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.

SECTION 7. All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

ORDINANCE NO. 122

An Ordinance to amend Title X of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition; to amend Chapter 14, Section 3, Subsection (B), to revise Schedule V thereof providing for stop streets; to amend Chapter 17, Section 24 of said Title to revise Schedule VII thereof prohibiting parking at all times on certain streets; to amend Chapter 17, Section 26 of said Title to revise schedule IX thereof prohibiting stopping, standing or parking on certain streets during certain hours; to amend Chapter 17, Section 27 of said title to revise Schedule X thereof limiting parking time on certain streets; to amend Chapter 25, Section 2 (C) of said title to revise Schedule I thereof providing 30 and 35 miles per hour speed limits on certain streets; providing other matters properly relating thereto; providing penalties for the violation hereof; and repealing all ordinances or parts of ordinances in conflict herewith.

The Board of Commissioners of the City of Las Vegas does ordain as follows:

SECTION 1. Title X, Chapter 14, Section 3, Subsection (B) of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended by adding to Schedule V thereof the following:

SCHEDULE V
Hassett Avenue at Bruce Street
Howard Avenue at Bruce Street
Camosa Avenue at Bruce Street
Benita Avenue at Bruce Street
Camosa Avenue at Atlantic Street
Las Vegas Expressway at Torrey Pines Drive

SECTION 2. Title X, Chapter 17, Section 24 of said Municipal Code is hereby amended by adding to Schedule VII thereof the following:

SCHEDULE VII
Charleston Boulevard — along both sides from Rancho Road to Decatur Boulevard
Bonanza Road — along the south side from 7th Street to 16th Street
Paradise Road — along the west side from Sahara Avenue to St. Louis Avenue
Evergreen Avenue — along the south side from Decatur Boulevard west a distance of 1000 feet

SECTION 3. Title X, Chapter 17, Section 26 of said Municipal Code is hereby amended by adding to Schedule IX thereof the following:

SCHEDULE IX
Eastern Avenue — along the east side from Ballard Drive to Oakey Boulevard (Monday through Friday, 7:00 A.M. to 9:00 A.M.)

SECTION 4. Title X, Chapter 17, Section 27 of said Municipal Code is hereby amended by adding to Schedule X thereof the following:

SCHEDULE X
Boston Avenue, from Commerce Avenue to Las Vegas Boulevard South, South side.
New York Avenue from 200 feet west of Commerce Avenue to West a distance of 200 feet, South.
Fairfield Avenue from Sahara Avenue to North a distance of 180 feet, East.

SECTION 5. Schedule I of Title X, Chapter 25, Section 2, Subsection (C) of said Municipal Code is hereby amended to read as follows:

SCHEDULE I

In accordance with Section 2(C), and when properly signposted, the speed limit shall be thirty miles per hour (30 mph) upon the following streets or portions thereof:

Main Street — between Owens Avenue and Las Vegas Boulevard South.
Las Vegas Boulevard South — between Bonanza Road and Sahara Avenue.
Bonnevillle Avenue — between Main Street and Maryland Parkway.
Fourth Street — between Stewart Avenue and Las Vegas Boulevard South.
Casino Center Boulevard — between Bonanza Road and Oakey Boulevard.

The speed limit shall be thirty-five miles per hour (35 mph) upon the following streets or highways or portions thereof:

Sahara Avenue — from Maryland Parkway to the westerly city limits.
Fremont Street — commonly known as Boulder Highway, beginning at 13th Street east to the easterly city limits.
Charleston Boulevard — for its entire length in the city.
Bonanza Road — between Tonopah Highway and 28th Street.
Rancho Road — between Charleston Boulevard and Bonanza Road.
Rancho Drive — between Charleston Boulevard and Sahara Avenue.
North 25th Street — between Charleston Boulevard and Sahara Avenue.

North 25th Street — between Charleston Boulevard and Owens Avenue.

Tonopah Highway — between Bonanza Road and Lake Mead Boulevard.

Highland Drive — between Lake Mead Boulevard and West Charleston.

Highland Drive — between Sahara Avenue and southerly city limits.

Oakey Boulevard — between Highland Drive and Valley View.

Vegas Drive — Owens Avenue — between Cherokee Lane and "H" Street.

Vegas Drive — between Tonopah Highway and Decatur Boulevard.

Las Vegas Boulevard North — between Bonanza Road and Owens Avenue.

Industrial Road — between Wyoming Avenue and Sahara Avenue.

Wyoming Avenue — Oakey Boulevard — between Main Street and Valley View; between Arville and Decatur Boulevard.

Smoke Ranch Road — between Decatur Boulevard and Tonopah Highway.

Decatur Boulevard — between Sahara Avenue and Tonopah Highway.

West Fremont — Decatur Boulevard to westerly city limits.

Washington Avenue — Tonopah Highway to Highland Drive.

Alta Drive — Rancho Road to Highland Drive.

Molave Road — between Bonanza Road and Washington Avenue.

Highland Drive — between Charleston Boulevard and Oakey Boulevard.

Oakey Boulevard — between Valley View Drive and Arville Street.

Western Street — between Highland Drive and Charleston Boulevard.

The speed limit shall be forty-five miles per hour (45 mph) upon the following streets or highways or portions thereof:

Bonanza Road — between 28th Street and Nellis Boulevard.
Tonopah Highway — between Vegas Drive and Decatur Boulevard.
Smoke Ranch Road — between Tonopah Highway and Clayton.
West Fremont — between Rancho Road and Decatur Boulevard.
Sahara Avenue — between Maryland Parkway and Boulder Highway.
Molave Road — from Bonanza Road to Charleston Boulevard.
Lamb Boulevard — from Charleston Boulevard to Owens Avenue.

The speed limit shall be fifty-five miles per hour (55 mph) upon the following streets or highways or portions thereof:

Tonopah Highway — between Decatur Boulevard and Cheyenne Road.

The speed limit shall be sixty-five miles per hour (65 mph) upon the following streets or highways or portions thereof:

Tonopah Highway — between Cheyenne Road and northerly city limits.

SECTION 6. Any person, firm or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the city jail for not more than six months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.

SECTION 7. All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.
