

ORDINANCE NO. 1415

AN ORDINANCE TO AMEND TITLE II, CHAPTER 5, SECTION 13 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, PROVIDING STANDARDS AND REGULATIONS FOR NURSERY SCHOOLS; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Title II, Chapter 5, Section 13 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

2-5-13: ADDITIONAL STANDARDS AND REGULATIONS; NURSERY SCHOOLS:

(A) Every Nursery School shall have a minimum of one (1) staff member who has been duly trained and certified as a nursery-kindergarten primary teacher, or kindergarten primary teacher by the Board of Education of the State of Nevada.

Every Nursery School teaching the Montessori Method shall have a minimum of one (1) staff member who has been duly trained and certified as a Montessori Primary Teacher by an accredited Montessori Training School, in lieu of the Nevada State teaching certificate required for regular primary nursery schools.

(B) Advertisements and statements of services available at a Nursery School shall be limited to such services and educational training as are specified in the license, and no advertising or statements or claims of specialized educational training or experience, or related services, shall be made unless authorized by the license.

SECTION 2. Any person, firm or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the city jail for not more than six months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.

SECTION 3. All ordinances or parts of ordinances, sections, subsections, phrases, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,

1960 Edition, in conflict herewith are hereby repealed.

ORDINANCE NO. 1415

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Title II, Chapter 5, Section 13 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

2-5-73: ADDITIONAL STANDARDS AND REGULATIONS; NURSERY SCHOOLS:

- (A) Every Nursery School shall have a minimum of one (1) staff member who has been duly trained and certified as a nursery-kindergarten, primary teacher, or kindergarten primary teacher by the Board of Education of the State of Nevada.
 Every Nursery School teaching the Montessori Method shall have a minimum of one (1) staff member who has been duly trained and certified as a Montessori Primary Teacher by an accredited Montessori Training School, in lieu of the Nevada State teaching certificate required for regular primary nursery schools.
- (B) Advertisements and statements of services available at a Nursery School shall be limited to such services and educational training as are specified in the license, and no advertising or statements or claims of specialized educational training or experience, or related services, shall be made unless authorized by the license.

SECTION 2. Any person, firm or corporation violating any of the provisions of this ordinance shall upon conviction thereof be punished by a fine of not more than \$500.00 and/or imprisonment in the city jail for not more than six months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.

SECTION 3. All ordinances or parts of ordinances, sections, subsections, phrases, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.
