

ORDINANCE NO. 1307

AN ORDINANCE TO AMEND ORDINANCE NO. 1289 OF THE CITY OF LAS VEGAS, NEVADA, ADOPTING BY REFERENCE AS PART 1 THE 1967 UNIFORM BUILDING CODE, VOLUME 1 THERE-
OF, AS PART 2 THE UNIFORM BUILDING CODE STANDARDS 1967 EDITION, AND AS PART 3
A SUPPLEMENTAL DOCUMENT PROVIDING AMENDMENTS, CHANGES AND DELETIONS TO THE
UNIFORM BUILDING CODE 1967, VOLUME 1, BY AMENDING SAID PART 3 BY ADDING THERETO
A NEW SECTION DESIGNATED AS SECTION 21A TO PROVIDE THE TYPES OF CONSTRUCTION PER-
MITTED IN FIRE ZONE 1; PROVIDING OTHER MATTERS PROPERLY RELATED THERETO; PROVIDING
PENALTIES FOR THE VIOLATION HEREOF AND REPEALING ALL ORDINANCES OR PARTS OF ORDI-
NANCES IN CONFLICT HERewith.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS
FOLLOWS:

SECTION 1. Ordinance No. 1289 of the City of Las Vegas, Nevada, is hereby
amended by adding to the supplemental document adopted by reference as Part 3 of the Build-
ing Code of the City of Las Vegas a new section, to be designated Section 21A, reading as
follows:

Section 21A. Section 1602 (a) is hereby amended to read as follows:

(a) GENERAL. Buildings or structures hereafter erected, constructed,
moved within or into Fire Zone No. 1 shall be of Type I, II or IV one-hour
construction and shall meet the requirements of this Section. Types III
H.T. and III one-hour shall be permitted if the building is provided with
approved automatic fire extinguishing system throughout. (For regulations
covering open parking garages see Section 1109.)

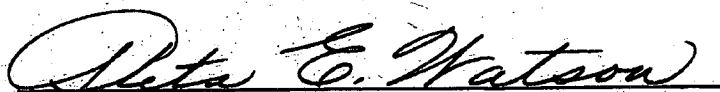
SECTION 2. Any person, firm or corporation violating any of the provisions of
this Ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00
and/or imprisonment in the City Jail for not more than six (6) months, or any combination of
such fine and imprisonment. Every day of such violation shall constitute a separate offense.

SECTION 3. All ordinances or parts of ordinances, sections, subsections,
phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of
Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

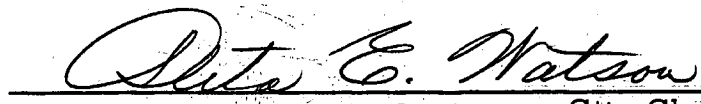

hereby amended to read as follows:

(a) GENERAL. Buildings or
structures hereafter erected, con-
structed, moved within or into Fire
Zone No. 1 shall be of Type I, II
or IV one-hour construction and
shall meet the requirements of this
Section. Types III H.T. and IH one-
hour shall be permitted if the build-
ing is provided with approved auto-
matic fire extinguishing system
throughout. (For regulations cover-
ing open parking spaces see Section
1109.)

SECTION 2. Any person, firm or
corporation violating any of the pro-
visions of this Ordinance shall, upon
conviction thereof, be punished by a
fine of not more than \$500.00 and/or
imprisonment in the City Jail for not
more than six (6) months, or any
combination of such fine and im-
prisonment. Every day of such viola-
tion shall constitute a separate
offense.

SECTION 3. All ordinances or
parts of ordinances, sections, subsec-
tions, phrases, sentences, clauses or
paragraphs contained in the Municipal
Code of the City of Las Vegas, Ne-
vada, 1960 Edition, in conflict here-
with are hereby repealed.
