

ORDINANCE NO. 1304

AN ORDINANCE AMENDING TITLE X, CHAPTER 3, SECTION 6 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING THE HOURS THAT PARKING METERS SHALL BE IN OPERATION IN THE DOWNTOWN CITY AREA DEFINED AS A PORTION OF MAIN STREET, FREMONT STREET AND ALONG THE WEST SIDE OF THIRD STREET BETWEEN OGDEN AND CARSON AVENUES, BUT NOT INCLUDING SAID LATTER AVENUES; PROVIDING HOURS OF OPERATION; PROVIDING RATES FOR PARKING ON CITY OWNED PARKING LOTS; PROVIDING OTHER MATTERS PROPERLY RELATED THERETO AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Title X, Chapter 3, Section 6 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

10-3-6: PARKING TIME LIMITS:

(A) Parking meters shall be operated in the parking meter zone every day between the hours of 9:00 A.M. and 6:00 P.M., except Sundays and legal holidays, and except hereinafter in Subsection (B)2 expressly provided. Within the meaning of this Chapter, the term "holiday" shall include the following days only: January 1, May 30, July 4, the first Monday in September, October 31, November 11, Thanksgiving Day, and December 25; provided, however, that by resolution of the majority of its members, the Board of Commissioners may extend the time for operation of any parking meters in the parking meter zone for an additional period of time; provided, that proper notice for such extended time of operation is placed on each such parking meter.

(B) 1. Parking or standing a vehicle in a designated parking meter space on the following named streets and parts of streets shall be lawful for six (6) minutes for each one cent (1 ¢) coin of the United States of America, or for thirty (30) minutes for each five cent (5¢) coin of the United States of America, or for sixty (60) minutes for each ten cent (10¢) coin of the United States of America, deposited in the meter for such parking meter space.

On Fremont Street from Third Street to Ninth Street;

On Carson Avenue from Main Street to Seventh Street;

On Ogden Avenue from Main Street to Sixth Street;

On Las Vegas Boulevard from Bridger Avenue to Stewart Avenue;

On the east side of Third Street from Carson Avenue to Ogden Avenue;

On Fourth Street, Sixth Street, Seventh Street and Eighth Street from

Carson Avenue to Ogden Avenue; limited, however, to such maximum total

time for parking as shall be prescribed by the order of the Board of Commissioners from time to time and so indicated by proper notice upon such parking meter; provided, however, that the Board of Commissioners may from time to time by resolution provide that parking meter heads shall be installed within the areas hereinabove set forth having thereon receptacles for a five cent (5¢) minimum only, and containing no receptacle for the deposit of one cent (1¢) coins, in which event the minimum parking time so designated shall be thirty (30) minutes for each five cent (5¢) coin of the United States of America.

2. Parking or standing a vehicle in a designated parking meter space on the following named streets and parts of streets shall be lawful for one (1) hour for each ten cent (10¢) coin of the United States of America, deposited in the meter for such parking meter space:

On Fremont Street from Main Street to and including the west side of Third Street;

On Main Street, First Street and Casino Center Boulevard between Ogden and Carson Avenues, but not including any portion of Ogden or Carson Avenues.

In the area herein designated in this Subsection (B)2, the depositing of a ten cent (10¢) coin of the United States of America for parking or standing a vehicle in a designated parking meter space therein shall be required between the hours of 9:00 A.M. and 6:00 P.M. each day, not including Sundays or holidays.

3. Parking or standing a vehicle in a designated parking meter space in any other portion of the parking meter zone shall be lawful for twelve (12) minutes for each one cent (1¢) coin of the United States of America, or for sixty (60) minutes for each five cent (5¢) coin of the United States of America, deposited in the meter for such parking meter space; limited, however, to such maximum total time for parking as shall be prescribed by the proper order of the Board of Commissioners from time to time and so indicated by proper notice placed upon such parking meter.

(C) Parking or standing a vehicle in any of the City owned parking lots, except the multiple parking garages located on Carson and Ogden Avenues which rates are established by resolution, shall be at the following rates:

1. In the Union Pacific North Lot and the Union Pacific South Lot, ten cent (10¢) coin of the United States of America for each one (1) hour,

twenty-five cent (25¢) coin of the United States of America for three (3) hours,
fifty cent (50¢) coin of the United States of America for six (6) hours and seventy-
five cent (75¢) coin of the United States of America for nine (9) hours;

2. In the Fourth and Stewart Lot (located on the West side of Fourth
Street between Stewart and Mesquite Streets, five cent (5¢) coin of the United
States of America for each one (1) hour and fifty cent (50¢) coin of the United
States of America for ten (10) hours;

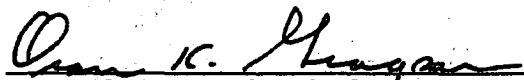
provided, however, that parking on such lots may be limited to such maximum total time as may
be prescribed by the proper order of the Board of Commissioners from time to time and so indi-
cated by proper notice placed upon the parking meters thereon.

(D) The City Traffic Engineer is hereby directed and authorized to mark off a
loading and unloading zone in the parking meter areas wherein commercial trucks may park
in the parking zones to load or unload merchandise without depositing coins for a period up
to and including the hour of 10:00 A.M. Should any truck or delivery car be parked in any
such designated loading zone to load or unload merchandise between the hours of 10:00 A.M.
and 6:00 P.M., except as in Subsection (A) of this Section, without depositing a coin, then
the violator shall be given a ticket and the legal penalty imposed.

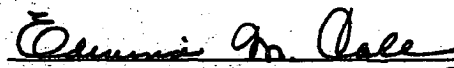
SECTION 2. Any person, firm or corporation violating any of the provisions of
this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00
and/or imprisonment in the City Jail for not more than six (6) months, or any combination of
such fine and imprisonment. Every day of such violation shall constitute a separate offense.

SECTION 3. All ordinances or parts of ordinances, sections, subsection, phrases,
sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas,
Nevada, 1960 Edition, in conflict herewith are hereby repealed.

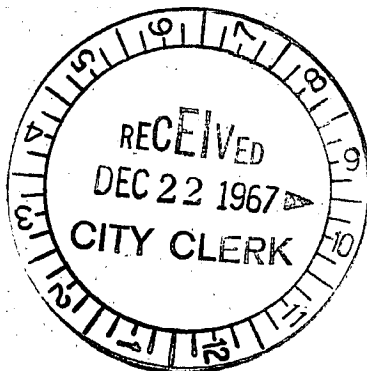

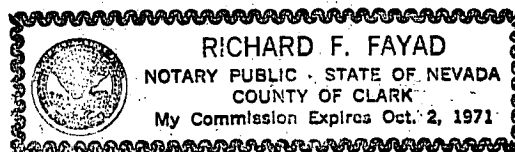

AN ORDINANCE AMENDING TITLE X, CHAPTER 3, SECTION 6 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING THE HOURS THAT PARKING METERS SHALL BE IN OPERATION IN THE DOWNTOWN CITY AREA DEFINED AS A PORTION OF MAIN STREET, FREMONT STREET AND ALONG THE WEST SIDE OF THIRD STREET BETWEEN OGDEN AND CARSON AVENUES, BUT NOT INCLUDING SAID LATTER AVENUES; PROVIDING HOURS OF OPERATION; PROVIDING RATES FOR PARKING ON CITY OWNED PARKING LOTS; PROVIDING OTHER MATTERS PROPERLY RELATED THERETO AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HERewith.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Title X, Chapter 3, Section 6 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

10-36: PARKING TIME LIMITS:

(A) Parking meters shall be operated in the parking meter zone every day between the hours of 9:00 A.M. and 6:00 P.M., except Sundays and legal holidays, and except hereinafter in Subsection (B)2 expressly provided. Within the meaning of this Chapter, the term "holiday" shall include the following days only: January 1, May 30, July 4, the first Monday in September, October 31, November 11, Thanksgiving Day, and December 25; provided, however, that by resolution of the majority of its members, the Board of Commissioners may extend the time for operation of any parking meters in the parking meter zone for an additional period of time; provided, that proper notice for such extended time of operation is placed on each such parking meter.

(B) 1. Parking or standing a vehicle in a designated parking meter space on the following named streets and parts of streets shall be lawful for six (6) minutes for each one cent (1c) coin of the United States of America, or for thirty (30) minutes for each five cent (5c) coin of the United States of America, or for sixty (60) minutes of each ten cent (10c) coin of the United States of America, deposited in the meter for such parking meter space.

On Fremont Street from Third Street to Ninth Street;
On Carson Avenue from Main Street to Seventh Street;
On Ogden Avenue from Main Street to Sixth Street;
On Las Vegas Boulevard from Bridger Avenue to Stewart Avenue;
On the east side of Third Street from Carson Avenue to Ogden Avenue;
On Fourth Street, Sixth Street, Seventh Street and Eighth Street from Carson Avenue to Ogden Avenue; limited, however, to such maximum total time for parking as shall be prescribed by the order of the Board of Commissioners from time to time and so indicated by proper notice upon such parking meter; provided, however, that the Board of Commissioners may from time to time by resolution provide that parking meter heads shall be installed within the areas hereinabove set forth having thereon receptacles for a five cent (5c) minimum only, and containing no receptacle for the deposit of one cent (1c) coins, in which event the minimum parking time so designated shall be thirty (30) minutes for each five cents (5c) coin of the United States of America.

2. Parking or standing a vehicle in a designated parking meter space on the following named streets and parts of streets shall be lawful for one (1) hour for each ten cent (10c) coin of the United States of America, deposited in the meter for such parking meter space:

On Fremont Street from Main Street to and including the west side of Third Street;
On Main Street, First Street and Casino Center Boulevard between Ogden and Carson Avenues, but not including any portion of Ogden or Carson Avenues.

In the area herein designated in this Subsection (B)2, the depositing of a ten-cent (10c) coin of the United States of America for parking or standing a vehicle in a designated parking meter space therein shall be required between the hours of 9:00 A.M. and 6:00 P.M. each day, not including Sundays or holidays.

3. Parking or standing a vehicle in a designated parking meter space in any other portion of the parking meter zone shall be lawful for twelve (12) minutes for each one cent (1c) coin of the United States of America, or for sixty (60) minutes for each five cent (5c) coin of the United States of America, deposited in the meter for such parking meter space; limited, however, to such maximum total time for parking as shall be prescribed by the proper order of the Board of Commissioners from time to time and so indicated by proper notice upon such parking meter.

(C) Parking or standing a vehicle in any of the City owned parking lots, except the multiple parking garages located on Carson and Ogden Avenues which rates are established by resolution, shall be at the following rates:

1. In the Union Pacific North Lot and the Union Pacific South Lot, ten cent (10c) coin of the United States of America for each one (1) hour, twenty-five cent (25c) coin of the United States of America for three (3) hours, fifty cent (50c) coin of the United States of America for six (6) hours

and seventy-five cent (75c) coin of the United States of America for nine (9) hours;

2. In the Fourth and Stewart Lot (located on the West side of Fourth Street between Stewart and Mesquite Streets, five cent (5c) coin of the United States of America for each one (1) hour and fifty cent (50c) coin of the United States of America for ten (10) hours; provided, however, that parking on such lots may be limited to such maximum total time as may be prescribed by the proper order of the Board of Commissioners from time to time and so indicated by proper notice placed upon the parking meters thereon.

(D) The City Traffic Engineer is hereby directed and authorized to mark off a loading and unloading zone in the parking meter areas wherein commercial trucks may park in the parking zones to load or unload merchandise without depositing coins for a period up to and including the hour of 10:00 A.M. Should any truck or delivery car be parked in any such designated loading zone to load or unload merchandise between the hours of 10:00 A.M. and 6:00 P.M., except as in Subsection (A) of this Section, without depositing a coin, then the violator shall be given a ticket and the legal penalty imposed.

SECTION 2. Any person, firm or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and or imprisonment in the City Jail for not more than six (6) months, or any combination of such fine or imprisonment. Every day of such violation shall constitute a separate offense.

SECTION 3. All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.
