

ORDINANCE NO. 1281

AN ORDINANCE TO AMEND TITLE V, CHAPTER 18 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY REPEALING SECTION 20 PROHIBITING SALE OF ALCOHOLIC LIQUOR ON ELECTION DAY; TO AMEND TITLE V, CHAPTER 18, SECTION 23, SUBSECTION (A) OF SAID MUNICIPAL CODE, CLARIFYING SALES OF LIQUORS TO MINORS; PROVIDING OTHER MATTERS PROPERLY RELATED THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH. (28)

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. Section 20, Chapter 18, Title V of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby repealed.

SECTION 2. Title V, Chapter 18, Section 23, Subsection (A) of said Municipal Code is hereby amended to read as follows:

5-18-23: SALES TO MINORS:

(A) It shall be unlawful for any licensee or other person to sell, furnish, dispose of, give, or cause to be sold, furnished, disposed of or given to a person under the age of twenty-one (21) years, alcoholic liquors.

SECTION 3. Any person, firm or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the City Jail for not more than six (6) months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.

SECTION 4. All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

SECTION 3. Any person, firm or
corporation violating any of the

Jail for a term of not more than six (6)
months, and every day of such
fine and imprisonment shall constitute a
separate offense.

or paragraphs contained in the Mun-
icipal Code of the City of Las Vegas,
Nevada, 1960 Edition, in conflict
herewith are hereby repealed.
