

ORDINANCE NO. 1271

AN ORDINANCE TO AMEND TITLE VI, CHAPTER 1, SECTION 2 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY MAKING IT UNLAWFUL TO LIE OR SLEEP IN THE STREET AND OTHER PUBLIC AND PRIVATE PLACES; PROVIDING OTHER MATTERS PROPERLY RELATED THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Title VI, Chapter 1, Section 2 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

6-1-2: It shall be unlawful for any person to lie or sleep on any street, sidewalk or alley in the city or to sleep or lodge in any otherwise vacant building or structure, or automobile or other vehicle without owning the same or without permission of the owner or person entitled to possession of the same, or to sleep in any vacant lot or public ground.

SECTION 2. Any person, firm or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the City Jail for not more than six (6) months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.

SECTION 3. All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

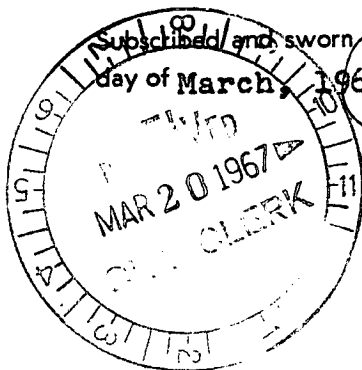
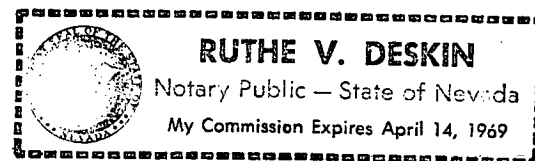

ORDINANCE No. 1273
AN ORDINANCE ANNEXING TO
AND MAKING A PART OF THE
CITY OF LAS VEGAS CERTAIN
SPECIFICALLY DESCRIBED TER-
RITORY ADJOINING AND CON-
TIGUOUS TO THE CORPORATE
LIMITS OF THE CITY OF LAS
VEGAS; DECLARING SAID TER-
RITORY AND INHABITANTS TO BE
ANNEXED THERETO AND SUB-
JECT TO ALL LAWS AND ORDIN-
ANCES; ORDERING A PLAT SHOW-
ING SAID TERRITORY TO BE
RECORDED IN THE OFFICE OF
THE COUNTY RECORDER OF THE
COUNTY OF CLARK, STATE OF
NEVADA, AND PROVIDING OTHER
MATTERS PROPERLY RELATED
THERE TO.

THE BOARD OF COMMISSION-
ERS OF THE CITY OF LAS VEGAS
DOES ORDAIN AS FOLLOWS:

SECTION 1. Pursuant to NRS
242A.210, and a hearing having been
set by the Clark County Annexation
Commission on the 20th day of De-
cember, 1966, and said Commission
having approved said annexation,
and pursuant to a hearing heaving
been scheduled before the Board of
City Commissioners on the 1st day
of February, 1967, and no person or
persons having appeared to object
to said annexation and the herein-
after described real property being
contiguous and adjacent to the ex-
terior boundaries of the City of Las
Vegas, the same are hereby an-
nexed to and included within the
boundaries of the City of Las Vegas,
Nevada. Said parcel is described as
follows, to-wit:

Government Lots 10 and 14 in
the Northwest Quarter (NW1/4) of
Section 1, Township 21, South,
Range 60 East, M.D.B.&M.

Together with the tenements,
property and inhabitants within said
parcel of real property, are hereby
declared to be a part of the City
of Las Vegas.

SECTION 2. Said parcel of real
property, together with the tene-
ments and inhabitants thereof, shall
be subject to the laws applicable to
the City of Las Vegas.

SECTION 3. The City Engineer of
the City of Las Vegas is hereby in-
structed to prepare plats of said
territory described in Section 1 of
this Ordinance and to file the same
for record in the Office of the Coun-
ty Recorder of Clark County, Nev-
ada.
