

EMERGENCY ORDINANCE NO. 1267

AN EMERGENCY ORDINANCE AMENDING TITLE V, CHAPTER 1, SECTION 10, SUBSECTION T, PARAGRAPH 10 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, TO PROVIDE THAT ANY TRAVELING SHOW AS THEREIN DEFINED WHICH DOES NOT REQUIRE POLICE SUPERVISION ON THE PART OF THE CITY OF LAS VEGAS OVER AND ABOVE THAT REQUIRED BY GENERAL BUSINESS LICENSEES SHALL BE LICENSED AT THE RATE OF \$ 25.00 PER DAY; PROVIDING FOR OTHER MATTERS PROPERLY RELATED THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT, AND DECLARING AN EMERGENCY.

WHEREAS, Title V, Chapter 1, Section 10, Subsection T, Paragraph 10 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, provides that traveling shows, as therein defined, shall pay the sum of One Hundred (\$100.00) Dollars per day as and for a license fee; and

WHEREAS, said sum is based in part on the fact that such shows normally require additional supervision on the part of the City; and

WHEREAS, the Board of Commissioners of the City of Las Vegas does hereby determine that traveling shows which do not require supervision over and above that normally required by business licensees shall not be charged said sum as and for a license fee; and

WHEREAS, said Board further determines that a reduction in such license fee is immediately necessary in order for merchants within the City of Las Vegas to utilize such traveling shows to stimulate business during the Christmas shopping season, and that therefore an emergency exists,

NOW, THEREFORE, the Board of Commissioners of the City of Las Vegas, Nevada, does hereby ordain as follows:

SECTION 1. Title V, Chapter 1, Section 10, Subsection T, Paragraph 10 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

10. Traveling Shows: Any proprietor, lessee or manager of any traveling show, traveling skating rink, circus, hippodrome, menagerie, or carnival intending to exhibit in the open air or under a tent or in any public hall, club room, assembly hall or theatre, where movable scenery and theatrical appliances are used for any performance or exhibition shall pay to the Director of License and Revenue the sum of \$100.00 as a license fee for the privilege of showing and exhibiting such traveling show, traveling skating rink, circus, hippodrome, menagerie or carnival

for each day; and upon payment therefor the Director of License and Revenue shall issue license for the day or number of days so paid for; provided, that nothing in this Subdivision contained shall be deemed or construed to require the holder of a theatre to procure any additional license to conduct, maintain, or carry on any theatrical or vaudeville performance when such performance is conducted at any theatre so licensed; and, provided further, that the license fee for any traveling show which does not, in the opinion of the Board of Commissioners of the City, require supervision on the part of the City over and above that normally required for general business licensees shall be in the sum of \$25.00 per day.

SECTION 2. All ordinances, parts of ordinances, chapters, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

SECTION 3. Any person, firm or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the City Jail for not more than six (6) months, or any combination of such fine and imprisonment. Every day of such violation constitutes a separate offense.

SECTION 4. By reason of the facts and determinations recited in the preamble of this ordinance, it is hereby declared that an emergency exists and that this ordinance is in the public interest and is necessary for the immediate preservation of the public peace, health, and safety of the inhabitants of the City of Las Vegas.

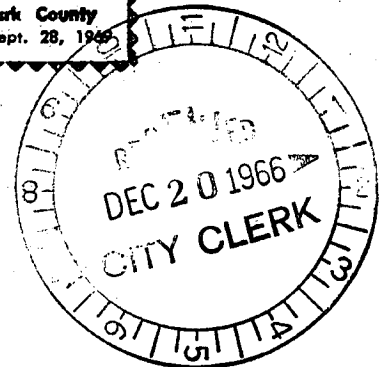
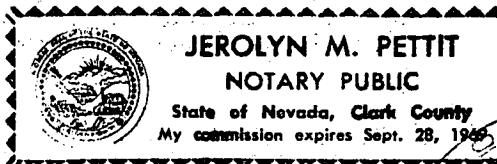

AN EMERGENCY ORDINANCE
AMENDING TITLE V, CHAPTER 1,
SECTION 10, SUBSECTION T, PARA-
GRAPH 10 OF THE MUNICIPAL CODE
OF THE CITY OF LAS VEGAS, NE-
VADA, 1960 EDITION TO PROVIDE
THAT ANY TRAVELING SHOW AS
THEREIN DEFINED WHICH DOES
NOT REQUIRE POLICE SUPERVISION
ON THE PART OF THE CITY OF LAS
VEGAS OVER AND ABOVE THAT RE-
QUIRED BY GENERAL BUSINESS LI-
CENSEES SHALL BE LICENSED AT
THE RATE OF \$25.00 PER DAY; PRO-
VIDING FOR OTHER MATTERS PRO-
PERLY RELATED THERETO; PROVID-
ING PENALTIES FOR THE VIOLATION
HEREOF; REPEALING ALL ORDIN-
ANCES OR PARTS OF ORDINANCES
IN CONFLICT, AND DECLARING AN
EMERGENCY.

WHEREAS, Title V, Chapter 1, Section 10, Subsection T, Paragraph 10 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, provides that traveling shows, as therein defined, shall pay the sum of One Hundred (\$100.00) Dollars per day as and for a license fee; and

WHEREAS, said sum is based in part on the fact that such shows normally require additional supervision on the part of the City; and

WHEREAS, the Board of Commissioners of the City of Las Vegas does hereby determine that traveling shows which do not require supervision over and above that normally required by business licensees shall not be charged said sum as and for a license fee; and WHEREAS, said Board further determines that a reduction in such license fee is immediately necessary in order for merchants within the City of Las Vegas to utilize such traveling shows to stimulate business during the Christmas shopping season, and that therefore an emergency exists,

NOW, THEREFORE, the Board of Commissioners of the City of Las Vegas, Nevada, does hereby ordain as follows:

SECTION 1. Title V, Chapter 1, Section 10, Subsection T, Paragraph 10 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

10. Traveling Shows: Any proprietor, lessee or manager of any traveling show, traveling skating rink, circus, hippodrome, menagerie, or carnival intending to exhibit in the open air or under a tent or in any public hall, club room, assembly hall or theatre, where movable scenery and theatrical appliances are used for any performance or exhibition shall pay to the Director of License and Revenue the sum of \$100.00 as a license fee for the privilege of showing and exhibiting such traveling show, traveling skating rink, circus, hippodrome, menagerie or carnival for each day; and upon payment thereof the Director of License and Revenue shall issue license for the day or number of days so paid for; provided, that nothing in this Subdivision contained shall be deemed or construed to require the holder of a theatre to procure additional license to conduct, maintain, or carry on any theatrical or vaudeville performance when such performance is conducted at any theatre so licensed; and, provided further, that the license fee for any traveling show which does not, in the opinion of the Board of Commissioners of the City, require supervision on the part of the City over and above that normally required for general business licensees shall be in the sum of \$25.00 per day.

SECTION 2. All ordinances, parts of ordinances, chapters, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby

repealed.

SECTION 3. Any person, firm or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and - or imprisonment in the City Jail for not more than six (6) months, or any combination of such fine and imprisonment. Every day of such violation constitutes a separate offense.

SECTION 4. By reason of the facts and determinations recited in the preamble of this ordinance, it is hereby declared that an emergency exists and that this ordinance is in the public interest and is necessary for the immediate preservation of the public peace, health, and safety of the inhabitants of the City of Las Vegas.
