

ORDINANCE NO. 1266

AN ORDINANCE ANNEXING TO AND MAKING A PART OF THE CITY OF LAS VEGAS CERTAIN SPECIFICALLY DESCRIBED TERRITORY ADJOINING AND CONTIGUOUS TO THE CORPORATE LIMITS OF THE CITY OF LAS VEGAS; DECLARING SAID TERRITORY AND INHABITANTS TO BE ANNEXED THERETO AND SUBJECT TO ALL LAWS AND ORDINANCES; ORDERING A PLAT SHOWING SAID TERRITORY TO BE RECORDED IN THE OFFICE OF THE COUNTY RECORDER OF THE COUNTY OF CLARK, STATE OF NEVADA, AND PROVIDING OTHER MATTERS PROPERLY RELATED THERETO.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Pursuant to Section 22, Chapter 484, Statutes of Nevada 1965, and a hearing having been set by the Clark County Annexation Commission on the 11th day of October, 1966, and said Commission having approved said annexation, and pursuant to a hearing having been scheduled before the Board of City Commissioners on the 16th day of November, 1966, and no person or persons having appeared to object to said annexation and the hereinafter described real property being contiguous and adjacent to the exterior boundaries of the City of Las Vegas, the same are hereby annexed to and included within the boundaries of the City of Las Vegas, Nevada. Said parcel is described as follows, to-wit:

A portion of the East Half (E 1/2) of the Southeast Quarter (SE 1/4) of Section 19, Township 20 South, Range 61 East, M.D.B. & M., and more particularly described as follows:

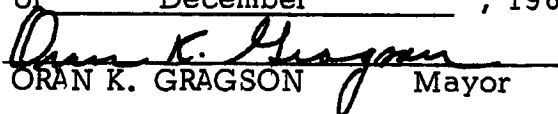
Commencing at the northwest corner of the Southwest Quarter (SW 1/4) of the Northeast Quarter (NE 1/4) of the Southeast Quarter (SE 1/4) of Section 19, Township 20 South, Range 61 East, M.D.B. & M.; thence South 00°24'02" West, along the West line of said Southwest Quarter (SW 1/4) of the Northeast Quarter (NE 1/4) of the Southeast Quarter (SE 1/4) 138.63 feet to a point on the North line of Spring Road, the true point of beginning; thence North 89°10'01" East along the North line of Spring Road 254.54 feet; thence North 53°17'41" East, continuing along the North line of said Spring Road 13.54 feet; thence South 36°42'19" East 150.00 feet; thence South 53°17'43" West 24.19 feet; thence South 00°25'51" West 222.94 feet; thence South 52°09'54" East 209.67 feet to a point on the North line of Melody Lane; thence South 08°01'50" West 301.47 feet to a point; thence southwesterly along the southeasterly right-of-way line of Melody Lane and its prolongation as shown on the Amended Plat of Eastland Heights Plat Number 1, to the point of intersection with the southwesterly right-of-way line of Hill Path as shown on the plat of Eastland Heights Tract Number 2; thence northwesterly along said southwesterly right-of-way line to the point of intersection with the South right-of-way line of Melody Lane as shown on said Plat of Eastland Heights Tract Number 2; thence West along said South right-of-way line to the West line of the East Half (E 1/2) of the Southeast Quarter (SE 1/4); thence North along said West line to the true point of beginning.

Together with the tenements, property and inhabitants within said parcel of real property, are hereby declared to be a part of the City of Las Vegas.

SECTION 2. Said parcel of real property, together with the tenements and inhabitants thereof, shall be subject to the laws applicable to the City of Las Vegas.

SECTION 3. The City Engineer of the City of Las Vegas is hereby instructed to prepare plats of said territory described in Section 1 of this Ordinance and to file the same for record in the Office of the County Recorder of Clark County, Nevada.

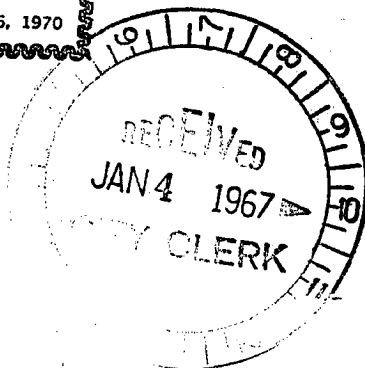
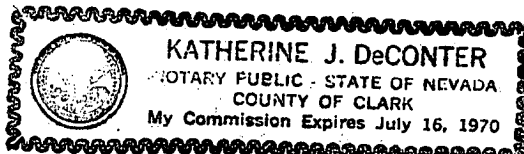

ORDINANCE NO. 1266
AN ORDINANCE ANNEXING TO AND MAKING A PART OF THE CITY OF LAS VEGAS CERTAIN SPECIFICALLY DESCRIBED TERRITORY ADJOINING AND CONTIGUOUS TO THE CORPORATE LIMITS OF THE CITY OF LAS VEGAS; DECLARING SAID TERRITORY AND INHABITANTS TO BE ANNEXED THERETO AND SUBJECT TO ALL LAWS AND ORDINANCES; ORDERING A PLAT SHOWING SAID TERRITORY TO BE RECORDED IN THE OFFICE OF THE COUNTY RECORDER OF THE COUNTY OF CLARK, STATE OF NEVADA, AND PROVIDING OTHER MATTERS PROPERLY RELATED THERETO.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Pursuant to Section 22, Chapter 484, Statutes of Nevada 1965, and a hearing having been set by the Clark County Annexation Commission on the 11th day of October, 1966, and said Commission having approved said annexation, and pursuant to a hearing having been scheduled before the Board of City Commissioners on the 16th day of November, 1966, and no person or persons having appeared to object to said annexation and the hereinafter described real property being contiguous and adjacent to the exterior boundaries of the City of Las Vegas, the same are hereby annexed to and included within the boundaries of the City of Las Vegas, Nevada. Said parcel is described as follows, to-wit:

A portion of the East Half (E 1/2) of the Southeast Quarter (SE 1/4) of Section 19, Township 20 South, Range 61 East, M.D.B.&M., and more particularly described as follows:

Commencing at the northwest corner of the Southwest Quarter (SW 1/4) of the Northeast Quarter (NE 1/4) of the Southeast Quarter (SE 1/4) of Section 19, Township 20 South, Range 61 East, M.D.B.&M.; thence South 00° 24'02" West, along the West line of said Southwest Quarter (SW 1/4) of the Northeast Quarter (NE 1/4) of the Southeast Quarter (SE 1/4) 138.63 feet to a point on the North line of Spring Road, the true point of beginning; thence North 89 degrees 10'01" East along the North line of Spring Road 254.54 feet; thence North 53 degrees 17' 41" East, continuing along the North line of said Spring Road 13.54 feet; thence South 36 degrees 42'19" East 150.00 feet; thence South 53 degrees 17'43" West 24.19 feet, thence South 00° 25'51" West 222.94 feet; thence South 52° 09' 54" East 209.67 feet to a point on the North line of Melody Lane; thence South 08 degrees 01'50" West 301.47 feet to a point; thence southwesterly along the southeasterly right-of-way line of Melody Lane and its prolongation as shown on the Amended Plat of Eastland Heights Plat Number 1, to the point of intersection with the southwesterly right-of-way line of Hill Path as shown on the plat of Eastland Heights Tract Number 2; thence northwesterly along said southwesterly right-of-way line to the point of intersection with the South right-of-way line of Melody Lane as shown on said Plat of Eastland Heights Tract Number 2; thence West along said South right-of-way line to the West line of the East Half (E 1/2) of the Southeast Quarter (SE 1/4); thence North along said West line to the true point of beginning.

Together with the tenements, property and inhabitants within said parcel of real property, are hereby declared to be a part of the City of Las Vegas.

SECTION 2. Said parcel of real property, together with the tenements and inhabitants thereof, shall be subject to the laws applicable to the City of Las Vegas.
