

ORDINANCE NO. 1265

AN ORDINANCE TO AMEND TITLE II, CHAPTER 11 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY REPEALING CHAPTER 11 AND PROVIDING A NEW CHAPTER TO BE DESIGNATED AS CHAPTER 11, CREATING A PARKS AND RECREATION ADVISORY COMMISSION; PROVIDING THAT THE DIRECTOR THEREOF SHALL SERVE AS EX OFFICIO SECRETARY OF SAID COMMISSION; PROVIDING FOR OTHER MATTERS PROPERLY RELATED THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. Title II, Chapter 11 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby repealed.

SECTION 2. Title II of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended by adding thereto a new chapter, designated as Chapter 11, to read as follows:

2-11-1: COMMISSION CREATED; MEMBERS: There is hereby created a Parks and Recreation Advisory Commission consisting of seven (7) or more members.

The Parks and Recreation Advisory Commission shall be appointed as follows:

(A) All members shall be appointed by the City Commission.

(B) Members of the Commission shall serve for a period of three (3) years.

(C) The first Commission to be appointed shall at the first meeting so classify its members by lot that two (2) shall serve for one (1) year; two (2) shall serve for two (2) years; and one (1) shall serve for three (3) years. All new or additional members shall serve for three (3) years from the date of appointment.

(D) At the expiration of each of the terms so provided for, a successor shall be appointed by the City Commission for a term of three (3) years.

(E) Vacancies in said Commission, occurring by something other than expiration of term, shall be filled by appointment by the Board of City Commissioners for the remainder of the term.

2-11-2: ORGANIZATION: The officers of the Commission shall be a chairman, a vice chairman, and a secretary. Within fifteen (15) days after the appointment of the Commission, the members shall meet in regular session and select from their members the chairman and the vice chairman. The secretary shall be the Director of Parks and Recreation of the City, but shall have no vote on the Commission. The duties of the officers of the Commission shall respectively be such as are usually carried by such officers. The officers shall hold office for one (1) year, or until their successors are selected.

The Commission shall adopt rules and regulations to govern procedures and shall, by vote, set a time for regular meetings which shall be held at least once a month, and shall determine the manner in which special meetings may be called, held, and the notice given. A majority of the regular members shall constitute a quorum for all purposes. Absence from two (2) consecutive regular meetings without formal consent of the Parks and Recreation Advisory Commission shall constitute sufficient grounds for the Board of City Commissioners, at its discretion, to remove said member and declare the position vacant. Minutes of meetings of the Commission shall be filed with the Clerk within ten (10) days following such meeting.

2-11-3: DUTIES: The duties of the Parks and Recreation Commission shall be:

(A) To act in an advisory capacity, in cooperation with the Director of Parks and Recreation, to the Board of City Commissioners on all matters pertaining to public parks and public recreation and to cooperate with other governmental agencies and civic groups in the advancement of sound park and recreation planning.

(B) To aid in defining areas of responsibility of the city, Clark County Fair and Recreation Board, Clark County, and the Clark County School District.

(C) To aid in coordinating the parks and recreation services with the program for other governmental agencies and other voluntary organizations.

(D) To assist in the functions of the Parks and Recreation Department with the public.

2-11-4: DIRECTOR OF PARKS AND RECREATION TO ATTEND MEETINGS:

The Director of Parks and Recreation or his representative shall attend all meetings of the Commission and shall serve as ex officio Secretary thereof.

SECTION 3. All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

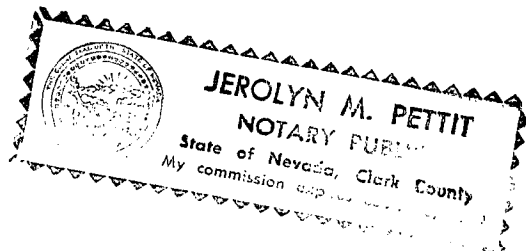

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. Title 11, Chapter 11 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby repealed.

SECTION 2. Title 11 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended by adding thereto a new chapter, designated as Chapter 11, to read as follows:

2-11-1:
COMMISSION CREATED; MEMBERS:
 There is hereby created a Parks and Recreation Advisory Commission, consisting of (7) members.

The Parks and Recreation Advisory Commission shall be appointed as follows:

- (A) All members shall be appointed by the City Commission.
- (B) Members of the Commission shall serve for a period of three (3) years.
- (C) The first Commission to be appointed shall at the first meeting so classify its members by lot that two (2) shall serve for one (1) year; two (2) shall serve for two (2) years; and one (1) shall serve for three (3) years. All new or additional members shall serve for three (3) years from the date of appointment.
- (D) At the expiration of each of the terms so provided for, a successor shall be appointed by the City Commission for a term of three (3) years.
- (E) Vacancies in said Commission, occurring by something other than expiration of term, shall be filled by appointment by the Board of City Commissioners for the remainder of the term.
