

ORDINANCE NO. 1392

AN ORDINANCE TO AMEND ORDINANCE NO. 1354 AND TO AMEND TITLE 5, CHAPTER 34, SECTION 5 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, PROVIDING FOR PERMIT FEES FOR EACH DANCE OR PROMOTIONAL ACTIVITY; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN
AS FOLLOWS:

SECTION 1. Ordinance No. 1354 and Title V, Chapter 34, Section 5 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

5-34-5: A permit fee of Ten (\$10.00) Dollars shall be charged for each dance. A permit fee of Twenty Five (\$25.00) Dollars shall be charged for each separate promotional activity other than those governed under Title 2, Chapter 7 of this Code.

SECTION 2. Any person, firm or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the City Jail for not more than six months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.

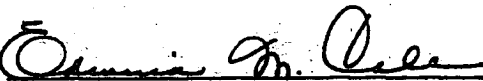

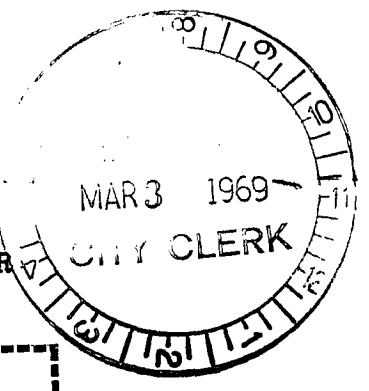
