

ORDINANCE NO. 1390

AN ORDINANCE TO AMEND TITLE VII, CHAPTER 1, SECTION 7 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, PROVIDING THAT EXISTING BUILDINGS REZONED P-R ARE DESIGNATED TO BE WITHIN FIRE ZONE 3; PROVIDING FOR OTHER MATTERS PROPERLY RELATED THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN
AS FOLLOWS:

SECTION 1. Title VII, Chapter 1, Section 7 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

7-1-7: REZONING TO ZONE NO. 2: Any areas hereafter rezoned by the Board of Commissioners of the City to C-1, C-2, or C-S, shall immediately upon such rezoning be considered in Fire Zone No. 2. Any areas hereafter granted a use permit or variance to conduct a professional or commercial use similar to the uses permitted in C-1, C-2, or C-S Zones shall immediately upon the granting of said use permit or variance be considered in Fire Zone No. 2.

EXCEPTION:

Existing buildings in any area rezoned to P-R are designated within Fire Zone 3.

SECTION 2. Any person, firm or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the City Jail for not more than six (6) months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.

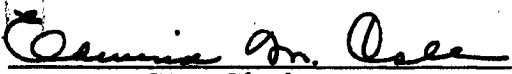
SECTION 3. All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

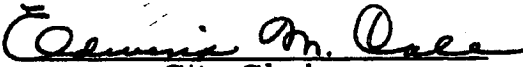

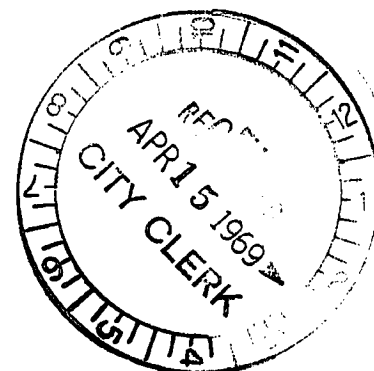
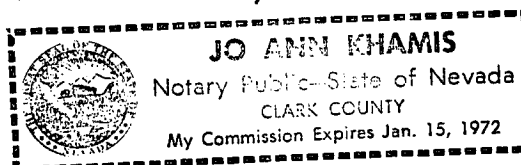
