

ORDINANCE NO. 1545

AN ORDINANCE TO AMEND TITLE II, CHAPTER 5, SECTION 2, SUBSECTION (E) TO PROVIDE THAT CHILDREN FROM TWO (2) THROUGH AND INCLUDING SIX (6) YEARS OF AGE MAY ATTEND NURSERY SCHOOL; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Title II, Chapter 5, Section 2, Subsection (E) of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

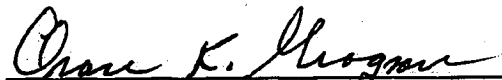
2-5-2- (E) A "Nursery School" is a facility which is equipped to provide educational experience exclusively for children from two (2) through and including six (6) years of age in the daytime only and not at night. The maximum number of children shall be limited by the nursery facilities.

SECTION 2. Any person, firm or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the city jail for not more than six (6) months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.

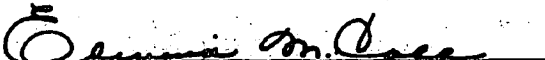

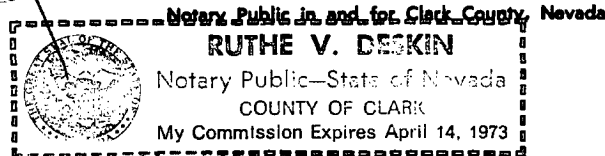

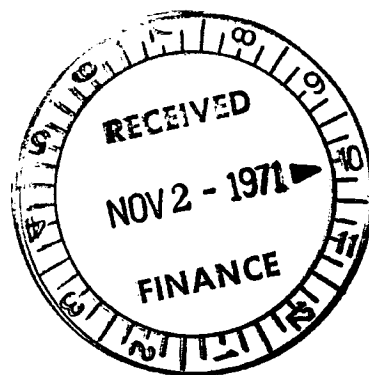
