

EMERGENCY ORDINANCE NO. 427

1 AN EMERGENCY ORDINANCE DECLARING THE DETERMINATION OF THE BOARD
2 OF COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, TO MAKE CERTAIN
3 PUBLIC IMPROVEMENTS IN THE CITY OF LAS VEGAS BY INSTALLING A SANI-
4 TARY SEWER ALONG CERTAIN STREETS AND PORTIONS OF STREETS THEREIN;
5 TO CREATE SANITARY SEWER IMPROVEMENT ASSESSMENT DISTRICT NO. 200-3
6 FOR THE PURPOSE OF MAKING SAID IMPROVEMENTS, AND TO DEFRAY THE
7 ENTIRE COSTS AND EXPENSE THEREOF BY SPECIAL ASSESSMENTS MADE AC-
8 CORDING TO THE FRONTAGE; FIXING A TIME IN WHICH PROTESTS AGAINST
9 THE PROPOSED IMPROVEMENTS OR THE CREATION OF SUCH DISTRICT MAY
10 BE HEARD AND CONSIDERED BY SAID BOARD, DIRECTING NOTICE THEREOF
11 TO BE GIVEN AND PROVIDING OTHER MATTERS RELATING THERETO.

12 WHEREAS, certain areas in the City of Las Vegas, Nevada,
13 are without adequate sewer improvements, and

14 WHEREAS, certain proceedings were heretofore taken by
15 the Board of Commissioners of the City of Las Vegas to make the
16 said improvements and to levy an assessment to defray the cost of
17 making the same, and

18 WHEREAS, the bonds for said improvement are not saleable
19 due to the lack of a favorable opinion by bonding attorneys, and

20 WHEREAS, the Board of Commissioners of the City of Las
21 Vegas has determined that it is for the best interests of the
22 City that the proceedings heretofore taken be abandoned and that
23 the steps for the creation of the assessment district and the con-
24 struction therein of improvements be started anew, and

25 WHEREAS, the said Board of Commissioners deems it exped-
26 ient and desirable to create Sanitary Sewer Assessment District
27 No. 200-3 for the purpose of installing along certain streets and
28 portions of streets hereinafter particularly described, a sani-
29 tary sewer composed of vitrified clay pipe, and to defray the
30 entire cost and expense thereof by special assessments made ac-
31 cording to frontage against the owners and assessable lots, prem-
32 ises and property specially benefited by such improvements and
included within said district, and

WHEREAS, there is not included within said district any
lands belonging to the City or public grounds not taxable, and in
no case does the estimated amount of any special assessment upon
any lot or premise for said improvements exceed 50% of the value
of such lot or premise as shown upon the latest tax list or as-
sessment roll for State and County tax, and

WHEREAS, in the judgment of the Board of Commissioners
of said City of Las Vegas, it is fair and equitable that no
portion of said cost and expense be borne by the City from its
general funds; and

WHEREAS, at a regular meeting of the Board of Commis-
sioners of the City of Las Vegas, held on the 11th day of October,
1950, upon motion of Commissioner Moore and duly seconded
by Commissioner Whipple and unanimously carried, a resolu-
tion was adopted and approved directing the City Engineer to make
estimates of the expense thereof and plats, diagrams and plans of
work and of the locality to be improved, and to file such esti-
mates, plats, diagrams and plans with the City Clerk for public
examination, and

WHEREAS, on the 18th day of October, 1950, said
estimates, plats, diagrams and plans were so filed.

NOW, THEREFORE, THE BOARD OF COMMISSIONERS OF THE CITY
OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

1 Section 1. That the Board of Commissioners of the City
2 of Las Vegas, Nevada, does hereby declare its determination to
3 make certain public improvements by installing a sanitary sewer
4 along certain streets and parts of streets therein, to create a
5 special assessment district therefor, and to defray the entire
6 cost and expense by special assessments made according to frontage
7 against the owners and upon the assessable lots and premises
8 specially benefited by such improvements and included within said
9 district.

10 Section 2. That the Board proposes to make said im-
11 provements by installing a sanitary sewer in and along certain
12 streets and portions of streets therein, said sewer to be composed
13 of eight and ten inch vitrified clay pipe, together with such ap-
14 purtenances as may be required, as is more particularly shown by
15 the plats, diagrams and plans of the work and locality to be im-
16 proved, now on file in the office of the City Clerk of the City of
17 Las Vegas.

18 Section 3. That the streets and parts of streets in and
19 along which the Board proposes to install ten inch vitrified clay
20 pipe, are the following:

21 From existing manhole at South 5th Street and Oakey
22 Blvd westerly along extension of Oakey Blvd to the
23 point Oakey Blvd intersects with "A" Street at the
24 east boundary of Meadows Addition; south along east
25 boundary of Meadows Addition, also known as "A" Street,
26 to center line of New York Avenue; New York Avenue
27 from east boundary to west boundary of Meadows Addition.

28 That the streets and parts of streets in and along which
29 the Board proposes to install eight inch vitrified clay pipe, are
30 the following:

31 South along east boundary of Meadows Addition, also
32 known as "A" Street, from the center line of New York
Avenue to center line of Boston Avenue; Fairfield Avenue
from New York Avenue to a manhole 123 ft south of center
line of St. Louis Avenue; from manhole in Fairfield
Avenue 123 ft south of center line of St. Louis Avenue;
across Fairfield Plaza to Boston Avenue; thence to west
boundary of Meadows Addition; Boston Avenue from east
boundary of Meadows Addition 470 ft west; Chicago Avenue,
Philadelphia Avenue, St. Louis Avenue, Cleveland Avenue,
Cincinnati Avenue, from Fairfield Avenue to west boundary
of Meadows Addition; Chicago Avenue and Philadelphia Avenue
from east boundary of Meadows Addition 441 ft west; St.
Louis Avenue from east boundary of Meadows Addition 416
ft west; Baltimore Avenue from existing manhole in South
5th Street to west boundary of Meadows Addition; Fairfield
Avenue from 145 ft north of center line of Baltimore Avenue
to Cincinnati Avenue; all of the streets hereinabove men-
tioned being located in the Meadows Addition to the City
of Las Vegas.

33 Section 4. That the special assessment district which
34 it is proposed to create, shall be designated Sanitary Sewer Im-
35 provement Assessment District No. 200-3, and shall include all the
36 lots, premises and property to the full depth of such, fronting,
37 adjoining and abutting on said streets and parts of streets, ex-
38 cepting those lots, premises and properties fronting, adjoining
39 and abutting on the following described street, to-wit:

1 The extension of Oakey Blvd from existing manhole at
2 South Fifth Street to the point Oakey Blvd intersects
3 with "A" Street at the east boundary of Meadows Addi-
4 tion.

5 Section 5. The Board of Commissioners of the City of
6 Las Vegas will meet at the City Hall in said City on the 15
7 day of November, 1950, at the hour of 3:30 o'clock, P M.,
8 to hear and consider any suggestions and objections that may be
9 made by parties in interest to the proposed improvements or any
10 matters relating thereto. Objections to said proposed improve-
11 ments or any matters relating thereto may be filed in writing at
12 the office of the City Clerk at any time prior to said meeting.

13 Section 6. That the City Clerk of the City of Las Vegas
14 shall keep the plats, diagrams and plans of the work and locality
15 to be improved together with the estimates of expense thereof on
16 file in her office for public inspection and examination, and
17 shall give notice of the filing of said estimates, plats, diagrams
18 and plans with the City Clerk for examination, of the proposed
19 improvements or work, of the location of the improvement, of the
20 district to be assessed, and of the time the Board will meet and
21 consider any suggestions and objections that may be made by part-
22 ies in interest to the proposed improvements. Said notice shall
23 be given by publication for at least two weeks in the Las Vegas
24 Review Journal, a daily newspaper published in the City of Las
25 Vegas every day each week except Saturday, by fourteen insertions
26 therein, and at least fifteen days prior to said meeting by post-
27 ing said notices in at least three public places in each ward and
28 by posting said notice in or near said post office of said City
29 and by posting notices in three public places near the site of
30 said proposed work. Said notice shall be in substantially the
31 following form:

1 NOTICE OF DETERMINATION AND INTENTION TO INSTALL A SAN-
2 ITARY SEWER SYSTEM ALONG CERTAIN STREETS AND PORTIONS OF STREETS,
3 TO CREATE SANITARY SEWER ASSESSMENT DISTRICT NO. 200-3, AND TO
4 DEFRAY THE ENTIRE COST BY SPECIAL ASSESSMENTS, AND OF THE HEARING
5 THEREFOR.

6 NOTICE IS HEREBY GIVEN that on October 25, 1950, the
7 Board of Commissioners and Mayor of the City of Las Vegas, Nevada,
8 adopted and approved an ordinance declaring the Board's determin-
9 ation to make certain public improvements by installing a sewer
10 system along certain streets and parts of streets therein, com-
11 posed of eight and ten inch vitrified clay pipe, together with
12 such appurtenances as may be required, to create a special as-
13 sessment district designated Sanitary Sewer Improvement Assess-
14 ment District No. 200-3 therefor, and to defray the entire cost
15 and expense thereof by special assessments made according to
16 frontage against the owners and the assessable lots, premises
17 and property specially benefited by such improvements and includ-
18 ed within said district.

19 The streets and parts of streets in and along which the
20 Board proposes to install ten inch vitrified clay pipe, are the
21 following:

22 From existing manhole at South 5th Street and Oakey
23 Blvd westerly along extension of Oakey Blvd to the
24 point Oakey Blvd intersects with "A" Street at the
25 east boundary of Meadows Addition; south along east
26 boundary of Meadows Addition, also known as "A"
27 Street, to center line of New York Avenue; New York
28 Avenue from east boundary to west boundary of Meadows
29 Addition.

30 The streets and parts of streets in and along which the
31 Board proposes to install eight inch vitrified clay pipe, are the
32 following:

33 South along east boundary of Meadows Addition, also
34 known as "A" Street, from the center line of New York
35 Avenue to center line of Boston Avenue; Fairfield
36 Avenue from New York Avenue to a manhole 123 ft south
37 of center line of St. Louis Avenue; from manhole in
38 Fairfield Avenue 123 ft south of center line of St.
39 Louis Avenue; across Fairfield Plaza to Boston Avenue;
40 thence to west boundary of Meadows Addition; Boston
41 Avenue from east boundary of Meadows Addition 470 ft
42 west; Chicago Avenue, Philadelphia Avenue, St. Louis
43 Avenue, Cleveland Avenue, Cincinnati Avenue, from
44 Fairfield Avenue to west boundary of Meadows Addition;
45 Chicago Avenue and Philadelphia Avenue from east bound-
46 ary of Meadows Addition 441 ft west; St. Louis Avenue
47 from east boundary of Meadows Addition 416 ft west;
48 Baltimore Avenue from existing manhole in South 5th
49 Street to west boundary of Meadows Addition; Fairfield
50 Avenue from 145 ft north of center line of Baltimore
51 Avenue to Cincinnati Avenue; all of the streets herein-
52 above mentioned being located in the Meadows Addition
53 to the City of Las Vegas.

54 ^{Sewer} Street Improvement Assessment District No. 200-3 shall
55 include all the lots, premises and property to the full depth of
56 such, fronting, adjoining and abutting upon said streets and parts
57 of streets, excepting: those lots, premises and properties fronting,
58 adjoining and abutting on the following described street, to-wit:
59 The extension of Oakey Blvd from existing manhole at
60 South Fifth Street to the point Oakey Blvd intersects
61 with "A" Street at the east boundary of Meadows Addition.

1 Said ordinance adopted and approved October 25, 1950
2 and the plats, diagrams and plans of the work and locality to be
3 improved, together with the estimates of the expense thereof, are
4 on file for public inspection and examination in the office of
5 the City Clerk of Las Vegas, Nevada, and all persons interested
6 are hereby referred to the same for further information.

7 Said Board of Commissioners will meet at the City Hall
8 at the corner of Stewart and 5th Streets in the City of Las Vegas,
9 Nevada, on the 15th day of November 1950, at 2:30 o'clock,
10 P. M., to hear and consider any suggestions and objections that
11 may be made by parties in interest to the proposed improvements,
12 or any matters relating thereto. Objections to said proposed im-
13 provements, or any matters relating thereto, may be filed in writ-
14 ing in the office of the City Clerk at any time prior to said
15 meeting. Unless the owners of more than one-half of the frontage
16 to be assessed shall file written objections thereto, such im-
17 provement or work shall be ordered.

1 Section 7. That all by-laws, orders, resolutions and ordi-
2 nances, or parts of by-laws, orders, resolutions and ordinances,
in conflict with this ordinance, are hereby repealed.

3 Section 8. That if any one or more sections, sentences,
4 clauses or parts of this ordinance shall, for any reason, be ques-
tioned or be held invalid, such judgment shall not affect, impair
5 or invalidate the remaining provisions of this ordinance, but
shall be confined in its operation to the specific sections, sen-
6 tences, clauses or parts of this ordinance so held unconstitution-
al and invalid, and the inapplicability and invalidity of any
7 section, sentence, clause or part of this ordinance, in any one
or more instances shall not affect or prejudice in any way the
applicability and validity of this ordinance in any other instance.

8 Section 9. That by reason of the fact that the sewer system
9 of the City of Las Vegas is inadequate to meet the present and
future needs of the City and its inhabitants and that it is neces-
10 sary immediately to raise funds to extend said sewer system,
therefore, it is hereby declared that an emergency exists, and
11 that this ordinance is necessary for the immediate preservation of
the public peace, health and safety.

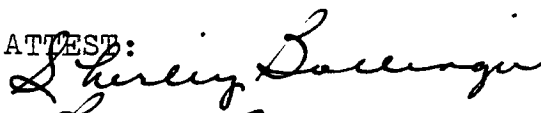
12 Section 10. That the City Clerk and Clerk of the Board of
13 Commissioners of the City of Las Vegas, shall cause this ordinance
to be published once a week for two successive weeks immediately
14 following its final reading and adoption, in the Las Vegas Review
Journal, a daily newspaper published in said City, and this ordi-
15 nance shall become effective immediately following the second
publication hereof.

Section 3. That the streets and parts of streets in and along which the Board proposes to install ten inch vitrified clay pipe, are the following:

From existing manhole at South 5th Street and Oakley Blvd westerly along extension of Oakley Blvd to the point Oakley Blvd intersects with "A" Street at the east boundary of Meadows Addition; south along east boundary of Meadows Addition, also known as "A" Street, to center line of New York Avenue; New York Avenue from east boundary to west boundary of Meadows Addition.

That the streets and parts of streets in and along which the Board proposes to install eight inch vitrified clay pipe, are the following:

South along east boundary of Meadows Addition, also known as "A" Street, from the center line of New York Avenue, to center line of Boston Avenue; Fairfield Avenue from New York Avenue to a manhole 123 ft south of center line of St. Louis Avenue; from manhole in Fairfield Avenue 123 ft south of center line of St. Louis Avenue; across Fairfield Plaza to Boston Avenue; thence to west boundary of Meadows Addition; Boston Avenue from east boundary of Meadows Addition 470 ft west; Chicago Avenue, Philadelphia Avenue, St. Louis Avenue, Cleveland Avenue, Cincinnati Avenue, from Fairfield Avenue to west boundary of Meadows Addition; Chicago Avenue and Philadelphia Avenue from east boundary of Meadows Addition 441 ft west; St. Louis Avenue from east boundary of Meadows Addition 416 ft west; Baltimore Avenue from existing manhole in South 5th Street to west boundary of Meadows Addition; Fairfield Avenue from 145 ft north of center line of Baltimore Avenue to Cincinnati Avenue; all of the streets hereinabove mentioned being located in the Meadows Addition to the City of Las Vegas.

Section 4. That the special assessment district which it is proposed to create, shall be designated Sanitary Sewer Improvement Assessment District No. 200-3, and shall include all the lots, premises and property to the full depth of such, fronting, adjoining and abutting on said streets and parts of streets, excepting those lots, premises and properties fronting, adjoining and abutting on the following described street, to-wit:

The extension of Oakley Blvd from existing manhole at South 5th Street to the point Oakley Blvd intersects with "A" Street at the east boundary of Meadows Addition.

Section 5. The Board of Commissioners of the City of Las Vegas will meet at the City Hall in said City on the 15th day of November, 1950, at the hour of 3:30 o'clock, P.M., to hear and consider any suggestions and objections that may be made by parties in interest to the proposed improvements or any matters relating thereto. Objections to said proposed improvements or any matters relating thereto may be filed in writing at the office of the City Clerk at any time prior to said meeting.

Section 6. That the City Clerk of

the City of Las Vegas shall keep the plats, diagrams and plans of the work and locality to be improved together with the estimates of expense thereof on file in her office for public inspection and examination, and shall give notice of the filing of said estimates, plats, diagrams and plans with the City Clerk for examination, of the proposed improvements or work, of the location of the improvement, of the district to be assessed, and of the time the Board will meet and consider any suggestions and objections that may be made by parties in interest to the proposed improvements. Unless the owners of more than one-half of the frontage to be assessed shall file written objections thereto, such improvement or work shall be ordered.

Section 7. That all by-laws, orders, resolutions and ordinances, or parts of by-laws, orders, resolutions and ordinances, in conflict with this ordinance, are hereby repealed.

Section 8. That if any one or more sections, sentences, clauses or parts of this ordinance shall, for any reason, be questioned or be held invalid, such judgment shall not affect, impair or invalidate the remaining provisions of this ordinance, but shall be confined in its operation to the specific sections, sentences, clauses or parts of this ordinance so held unconstitutional and invalid, and the inapplicability and invalidity of any section, sentence, clause or part of this ordinance, in any one or more instances shall not affect or prejudice in any way the applicability and validity of this ordinance in any other instance.

Section 9. That by reason of the fact that the sewer system of the City of Las Vegas is inadequate to meet the present and future needs of the City and its inhabitants and that it is necessary immediately to raise funds to extend said sewer system, therefore, it is hereby declared that an emergency exists, and that this ordinance is necessary for the immediate preservation of the public peace, health and safety.

Section 10. That the City Clerk and Clerk of the Board of Commissioners of the City of Las Vegas, shall cause this ordinance to be published once a week for two successive weeks immediately following its final reading and adoption, in the Las Vegas Review Journal, a daily newspaper published in said City, and this ordinance shall become effective immediately following the second publication hereof.

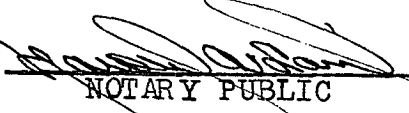
