

ORDINANCE NO. 446

AN ORDINANCE TO AMEND SECTIONS 1 AND 2 OF ORDINANCE NO. 360 OF THE CITY OF LAS VEGAS ENTITLED: "AN ORDINANCE ESTABLISHING A REGIONAL PLANNING COMMISSION AND AUTHORIZING THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS, CLARK COUNTY, NEVADA, TO COLLABORATE WITH THE GOVERNING BODIES OF INCORPORATED CITIES IN CLARK COUNTY, NEVADA, AND THE BOARD OF COUNTY COMMISSIONERS OF CLARK COUNTY, NEVADA, FOR THE CREATION OF A REGIONAL PLANNING COMMISSION." ALSO REFERRED TO AS CHAPTER 24, SECTIONS 1 AND 2 OF THE LAS VEGAS CITY CODE, AND TO REPEAL SECTIONS 3 AND 4 OF ORDINANCE NO. 360 ALSO REFERRED TO AS CHAPTER 24, SECTIONS 3 AND 4 OF THE LAS VEGAS CITY CODE.

The Board of Commissioners of the City of Las Vegas do ordain as follows:

Section 1. Section 1 of Ordinance No. 360 and also referred to as Chapter 24, Section 1 of the Las Vegas City Code is hereby amended to read as follows:

There is hereby created a Regional Planning Commission pursuant to Section 4 of Section 5063.03 NCL to consist of seven (7) members, three members of which shall be appointed by the Mayor and Board of Commissioners of the City of Las Vegas, three members of which shall be appointed by the Board of County Commissioners of the County of Clark, (and one member of which shall be appointed by the Mayor and Board of Commissioners of the City of North Las Vegas.)

Section 2. Section 2 of Ordinance No. 360 and also referred to as Chapter 24, Section 2 of the Las Vegas City Code is hereby amended to read as follows:

The term of office of each member of said Regional Planning Commission shall be six years or until his successor is appointed and qualifies except that the respective terms of the members first so appointed shall be one for a one-year term; one for a two-year term; one for a three-year term; one for a four-year term; one for a five-year term; and two for a six year term. All appointments to fill vacancies shall be for the unexpired term. All vacancies occurring in the Regional Planning Commission shall be filled by appointment by the governing body which first made the appointment.

Section 3. Section 3 of Ordinance No. 360 also referred to as Chapter 24, Section 3 of the Las Vegas City Code is hereby repealed.

Section 4. Section 4 of Ordinance No. 360 also referred to as Chapter 24, Section 4 of the Las Vegas City Code is hereby repealed.

Section 5. The City Clerk and Clerk of the Board of Commissioners of the City of Las Vegas shall cause this Ordinance No. 446 to be published once a week for two successive weeks immediately following its final reading and adoption, in the Las Vegas Review Journal, a daily newspaper published in the City of Las Vegas.

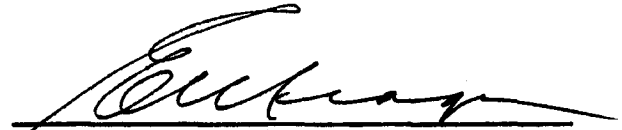

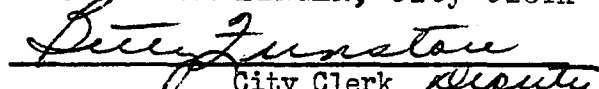

AN ORDINANCE TO AMEND SEC-
TIONS 1 AND 2 OF ORDINANCE
NO. 360 OF THE CITY OF LAS
VEGAS ENTITLED: "AN ORDI-
NANCE ESTABLISHING A RE-
GIONAL PLANNING COMMISSION
AND AUTHORIZING THE BOARD
OF COMMISSIONERS OF THE
CITY OF LAS VEGAS, CLARK
COUNTY, NEVADA, TO COLLABO-
RATE WITH THE GOVERNING
BODIES OF INCORPORATED CI-
TIES IN CLARK COUNTY, NEV-
ADA, AND THE BOARD OF
COUNTY COMMISSIONERS OF
CLARK COUNTY, NEVADA, FOR
THE CREATION OF A REGIONAL
PLANNING COMMISSION." ALSO
SECTIONS 1 AND 2 OF THE LAS
VEGAS CITY CODE, AND TO RE-
PEAL SECTIONS 3 AND 4 OF
ORDINANCE NO. 360 ALSO RE-
FERRED TO AS CHAPTER 24,
SECTIONS 3 AND 4 OF THE LAS
VEGAS CITY CODE.

The Board of Commissioners of the
City of Las Vegas do ordain as fol-
lows:

SECTION 1. Section 1 of Ordinance
No. 360 and also referred to as Chap-
ter 24, Section 1 of the Las Vegas
City Code is hereby amended to read
as follows:

There is hereby created a Region-
al Planning Commission pursuant
to Section 4 of Section 5063.03
NCL to consist of seven (7)
members, three members of
which shall be appointed by the
Mayor and Board of Commis-
sioners of the City of Las Vegas,
three members of which shall be
appointed by the Board of County
Commissioners of the County of
Clark, and one member of which
shall be appointed by the Mayor
and Board of Commissioners of
the City of North Las Vegas.

SECTION 2. Section 2 of Ordinance
No. 360 and also referred to as Chap-
ter 24, Section 2 of the Las Vegas
City Code is hereby amended to read
as follows:

The term of office of each mem-
ber of said Regional Planning
Commission shall be six years or
until his successor is appointed
and qualifies except that the res-
pective terms of the members
first so appointed shall be one
for a one-year term; one for a
two-year term; one for a three-
year term; one for a four-year
term; one for a five-year term;
and two for a six year term.
All appointments to fill vacancies
shall be for the unexpired term.
All vacancies occurring in the Re-
gional Planning Commission shall
be filled by appointment by the
governing body which first made
the appointment.

SECTION 3. Section 3 of Ordinance
No. 360 also referred to as Chapter
24, Section 3 of the Las Vegas City
Code is hereby repealed.

SECTION 4. Section 4 of Ordinance
No. 360 also referred to as
Chapter 24, Section 4 of the Las
Vegas City Code is hereby repealed.

SECTION 5. The City Clerk and
Clerk of the Board of Commissioners
of the City of Las Vegas shall cause
this Ordinance No. 446 to be pub-
lished once a week for two succes-
sive weeks immediately following its
final reading and adoption, in the
Las Vegas Review Journal, a daily
newspaper published in the City of
Las Vegas.
