ORDINANCE NO. 3248

AN ORDINANCE RELATING TO ZONING; AMENDING TITLE 19, CHAPTER 4, SECTION 930, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, TO CONFORM THE DEFINITION OF "MOBILE HOME PARK" FOR PURPOSES OF SAID TITLE 19 TO THE DEFINITION CONTAINED IN NRS 118B.017; AMENDING SECTION 60 OF CHAPTER 36 OF SAID TITLE 19 TO PROHIBIT THE DISPLAY FOR SALE OR SALE, OR BOTH, OF A MOBILE HOME WITHIN A MOBILE HOME PARK EXCEPT WITH RESPECT TO A SALE IN-PLACE, BY THE OWNER OR HIS AGENT, OF A MOBILE HOME THAT IS LOCATED AND OCCUPIED IN THE PARK BY SUCH OWNER; PROVIDING PENALTIES FOR VIOLATIONS HEREOF; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Amends the zoning regulations applicable to mobile home parks to clarify the types of mobile home sales uses that are prohibited therein.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
ORDAIN AS FOLLOWS:

SECTION 1: Title 19, Chapter 4, Section 930, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

19.04.930: "Mobile home park" means [a parcel of land which has been so designated and improved for the accommodation of] an area or tract of land where two or more mobile [home spaces, and related accessory structures, recreation facilities and open spaces.] homes or mobile home lots are rented or held out for rent. The term does not include an area or tract of land where more than half of the lots are rented overnight or for less than 3 months for recreational vehicles.

SECTION 2: Title 19, Chapter 36, Section 60, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

19.36.060: The following uses are expressly prohibited in the R-MHP District:

(A) Display [and/or sale] for sale or sale, or both, of mobile homes; [except a tenant may sell his mobile home.

1 residence;] provided, however, that this prohibition does not
2 apply to the sale in-place, by the owner or his agent, of a
3 mobile home that has previously been located and continuously
4 occupied in that mobile home park by such owner;

5 (B) Two-family and multifamily mobile homes and non-
6 mobile home dwelling units;

7 (C) Licensed mobile home [dealerships.] dealership or
8 any form of business office for mobile home sales;

9 (D) The placement of a mobile home within a mobile home
10 park for the purpose of sale or display, or both, as a sales
11 model; and

12 (E) For the purposes of this Section, a financial
13 institution that has succeeded to the interest in a mobile home
14 of an owner thereof through foreclosure shall be deemed to be the
15 agent of such owner.

16 SECTION 3: Whenever in this ordinance any act is
17 prohibited or is made or declared to be unlawful or an offense or
18 a misdemeanor, or whenever in this ordinance the doing of any act
19 is required or the failure to do any act is made or declared to
20 be unlawful or an offense or a misdemeanor, the doing of any such
21 prohibited act or the failure to do any such required act shall
22 constitute a misdemeanor and upon conviction thereof, shall be
23 punished by a fine of not more than \$1,000.00 or by imprisonment
24 for a term of not more than six (6) months, or by any combination
25 of such fine and imprisonment. Any day of any violation of this
26 ordinance shall constitute a separate offense.

27 SECTION 4: If any section, subsection, subdivision,
28 paragraph, sentence, clause or phrase in this ordinance or any
29 part thereof, is for any reason held to be unconstitutional or
30 invalid or ineffective by any court of competent jurisdiction,
31 such decision shall not affect the validity or effectiveness of
32 the remaining portions of this ordinance or any part thereof.

1 The City Council of the City of Las Vegas, Nevada, hereby
2 declares that it would have passed each section, subsection, sub-
3 division, paragraph, sentence, clause or phrase thereof irrespec-
4 tive of the fact that any one or more sections, subsections, sub-
5 divisions, paragraphs, sentences, clauses or phrases be declared
6 unconstitutional, invalid or ineffective.

7 SECTION 5: All ordinances or parts of ordinances,
8 sections, subsections, phrases, sentences, clauses or paragraphs
9 contained in the Municipal Code of the City of Las Vegas, Nevada,
10 1983 Edition, in conflict herewith are hereby repealed.

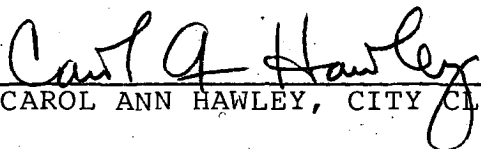
