18 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
19 ORDAIN AS FOLLOWS:

20 SECTION 1: The corporate limits of the City of Las
21 Vegas, Nevada, are hereby extended to include, annex to, and make
22 a part of the City of Las Vegas, Nevada, the following described
23 real property, to-wit:

24 Those portions of Township 21 South, Range 60 East,
25 M.D.M., in the County of Clark, State of Nevada,
26 described as follows:

27 PARCEL 1

28 Government Lots 13, 24, 25, 26, 27 and 28 of Section
29 2, Township 21 South, Range 60 East, M.D.M.

30 PARCEL 2

31 The North Half (N 1/2) of the Southwest Quarter (SW 1/4)
32 of Section 2, Township 21 South, Range 60 East, M.D.M.

PARCEL 3

Section 3, Township 21 South, Range 60 East, M.D.M.

EXCEPT THEREFROM Government Lots 5, 6, 14, 16 and 20
and the East Half (E 1/2) of Government Lot 7 of
said Section 3.

PARCEL 4

Section 4, Township 21 South, Range 60 East, M.D.M.

EXCEPT THEREFROM Government Lot 9 of said Section 4.

1 PARCEL 5

2 The North 2270.27 feet, measured along the East line,
3 of the East 1323.07 feet, measured along the North
4 line, of Section 5, Township 21 South, Range 60 East,
5 M.D.M.

6 SECTION 2: That said City Council has determined and
7 does hereby determine, that said described territory meets the
8 requirements provided by law for annexation to the City of Las
9 Vegas for the following reasons:

10 A. The area to be annexed was contiguous to the
11 City's boundaries at the time the annexation pro-
12 ceedings were instituted;

13 B. More than one-eighth (1/8) of the aggregate
14 external boundaries of the area are contiguous to the
15 City of Las Vegas;

16 C. The territory proposed to be annexed is not
17 included within the boundaries of another incor-
18 porated city or within the boundaries of any unin-
19 corporated town as those boundaries existed as of
20 July 1, 1983;

21 D. The City of Las Vegas is eligible to annex the
22 area described in this report because such area is
23 bounded on at least seventy-five percent (75%) of
24 its aggregate external boundaries by existing corporate
25 boundaries of the City of Las Vegas.

26 SECTION 3: The City of Las Vegas will provide police
27 protection through the Las Vegas Metropolitan Police Department,
28 fire protection, street maintenance, and library services
29 immediately upon annexation. Garbage collection by the company
30 franchised by the City will also be provided immediately. The
31 City sanitary sewer system will serve the proposed annexation
32 area. Any connection to or extension of this sewer line to serve
the annexation area shall be at the expense of the landowners.

1 Other services, such as participation in the City's recreational
2 programs, special educational classes and programs, public works
3 planning, building inspections, and other City Hall services
4 will also be available immediately. Utilities such as gas,
5 electricity, telephone, and water are provided by private utility
6 companies and other services to the area will not be affected by
7 annexation. Street paving, curbs and gutters, sidewalks and
8 street lights which are not in place at the time of annexation
9 will be installed in the presently developed areas upon the
10 request of the property owners and at their expense by means
11 of special assessment districts. Such improvements will be
12 extended into the undeveloped areas as development takes place
13 and the need therefor arises, and will be located according to
14 the needs of the area at that time. Such installations will
15 also be made at the expense of the property owners, either by
16 means of special assessment districts or as prerequisites to the
17 approval of subdivision plats or the issuance of building permits,
18 re-zonings, zone variances or special use permits.

19 SECTION 4: The annexation of said described territory
20 shall become effective on the 28th day of March, 1986, and on such
21 date the City of Las Vegas will have the funds appropriated in
22 sufficient amount to finance the extension into said described
23 territory of police protection, fire protection, street maintenance,
24 street sweeping, and street lighting maintenance.

25 SECTION 5: Said described territory, together with the
26 inhabitants and property thereof, shall, from and after the
27 28th day of March, 1986, be subject to all debts, laws, ordinances
28 and regulations in force in the City of Las Vegas and shall be
29 entitled to the same privileges and benefits as other parts of
30 said City, and shall be subject to municipal taxes levied by the
31 City of Las Vegas, Nevada.

32 SECTION 6: The City Engineer of the City of Las Vegas,

1 Nevada, is hereby instructed to cause to be prepared an accurate
2 map or plat of said described territory and to record the same,
3 together with a certified copy of this ordinance in the office of
4 the County Recorder of Clark County, Nevada, which said recording
5 shall be done prior to the 28th day of March, 1986.

6 SECTION 7: If any section, subsection, subdivision,
7 paragraph, sentence, clause or phrase in this ordinance or any
8 part thereof, is for any reason held to be unconstitutional, or
9 invalid or ineffective by any court of competent jurisdiction,
10 such decision shall not affect the validity or effectiveness of
11 the remaining portions of this ordinance or any part thereof. The
12 City Council of the City of Las Vegas hereby declares that it
13 would have passed each section, subsection, subdivision, para-
14 graph, sentence, clause or phrase thereof irrespective of the
15 fact that any one or more sections, subsections, subdivisions,
16 paragraphs, sentences, clauses or phrases be declared unconstitu-
17 tional, invalid or ineffective.

18 SECTION 8: All ordinances or parts of ordinances,
19 sections, subsections, phrases, sentences, clauses or paragraphs
20 contained in the Municipal Code of the City of Las Vegas, Nevada,
21 1983 Edition, in conflict herewith are hereby repealed.
