AN ORDINANCE RELATING TO CHILD CARE FACILITIES; AMENDING TITLE 6, CHAPTER 24, SECTION 384, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, TO REQUIRE CERTAIN QUALIFICATIONS FOR DIRECTORS OF INFANT AND TODDLER NURSERIES; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
ORDAIN AS FOLLOWS:

SECTION 1: Title 6, Chapter 24, Section 384 of the
Municipal Code of the City of Las Vegas, Nevada, 1983 Edition,
is hereby amended to read as follows:

6.24.384: A director of an infant and toddler nursery[, in
addition to any other requirement of this Chapter,
shall have at least nine months experience in the direct
care or supervision of infants in a continuously-operat-
ing institution, such as a hospital or infant nursery.]
in any facility must:

- (A) Have completed the training required to become a
professional nurse;
- (B) Have completed the training required to become a
Licensed Practical Nurse, and have at least six
months of verifiable experience in a program
related to the care of children under 3 years
of age;
- (C) Hold a credential as a "Child Development Associate
for Infants and Toddlers" issued by the Council
for Early Childhood Professional Recognition of
the National Association for the Education of Young

2 (D) Be at least 21 years of age and hold a high school
3 diploma or its equivalent, and have completed at
4 least 6 semester hours in child development,
5 education related to the health of children or,
6 in courses directly related to these fields, and
7 have at least 2 years of verifiable experience in
8 a program related to the care of children under 3
9 years of age; or

10 (E) Have a combination of education and experience
11 which in the judgment of the Child Welfare Board,
12 is equivalent to one of the requirements described
13 in paragraphs (A) to (D) inclusive.

14 In a facility where a facility director is not required,
15 the director of the nursery for infants and toddlers
16 shall ensure that the required number of persons on
17 the staff is maintained.

18 SECTION 2: If any section, subsection, subdivision,
19 paragraph, sentence, clause or phrase in this ordinance or any
20 part thereof, is for any reason held to be unconstitutional or
21 invalid or ineffective by any court of competent jurisdiction,
22 such decision shall not affect the validity or effectiveness of
23 the remaining portions of this ordinance or any part thereof.
24 The City Council of the City of Las Vegas, Nevada, hereby declares
25 that it would have passed each section, subsection, subdivision,
26 paragraph, sentence, clause or phrase thereof, irrespective of
27 the fact that any one or more sections, subsections, subdivisions,
28 paragraphs, sentences, clauses or phrases be declared unconstitu-
29 tional, invalid or ineffective.

30 SECTION 3: Whenever in this ordinance any act is pro-
31 hibited or is made or declared to be unlawful or an offense or
32 a misdemeanor, or whenever in this ordinance the doing of any act

1 is required or the failure to do any act is made or declared to
2 be unlawful or an offense or a misdemeanor, the doing of any such
3 prohibited act or the failure to do any such required act shall
4 constitute a misdemeanor and upon conviction thereof, shall be
5 punished by a fine of not more than \$1,000.00 or by imprisonment
6 for a term of not more than six months, or by any combination of
7 such fine and imprisonment. Any day of any violation of this
8 ordinance shall constitute a separate offense.

9 SECTION 4: All ordinances or parts of ordinances,
10 sections, subsections, phrases, sentences, clauses or paragraphs
11 contained in the Municipal Code of the City of Las Vegas, Nevada,
12 1983 Edition, in conflict herewith are hereby repealed.

is required or the failure to do any act is made or declared to be unlawful or an offense or a misdemeanor, the doing of any such prohibited act or the failure to do any such required act shall constitute a misdemeanor and upon conviction thereof, shall be punished by a fine of not more than \$1,000.00 or by imprisonment for a term of not more than six months, or by any combination of such fine and imprisonment. Any day of any violation of this ordinance shall constitute a separate offense.

SECTION 4: All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, in conflict herewith are hereby repealed.

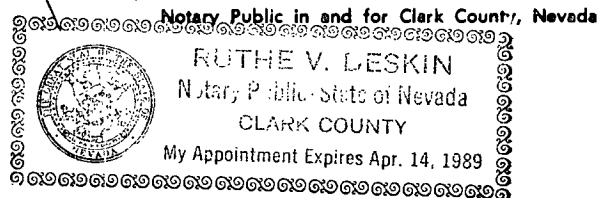
