AN ORDINANCE RELATING TO THE ADMINISTRATION OF THE CITY OF LAS VEGAS, AMENDING TITLE 2, CHAPTER 9, SECTION 50, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, TO ELIMINATE LAND DEVELOPMENT AS A DIVISION OF THE DEPARTMENT OF COMMUNITY PLANNING; AMENDING TITLE 2, CHAPTER 9, SECTION 150 OF SAID TITLE AND CHAPTER TO ESTABLISH LAND DEVELOPMENT SERVICES AS A DIVISION OF THE DEPARTMENT OF PUBLIC WORKS; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO, AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Changes Title of Land Development Division to Land Development Services and Transfers Function from Department of Community Planning and Development to Department of Public Works

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 2, Chapter 9, Section 50, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

2.09.050: The Department of Community Planning shall consist of the following divisions:

- (A) Planning;
- (B) Current planning[;
- (C) Land development.].

SECTION 2: Title 2, Chapter 9, Section 150, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

2.09.150: The Department of Public Works shall consist of the following divisions:

- (A) Electrical;
- (B) Streets;
- (C) Demand services;

- (D) Sanitation;
(E) City engineering;
(F) Public Services[.];
(G) Land Development Services.

SECTION 3: If any section, subsection, subdivision, paragraph, sentence clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas, Nevada, hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

SECTION 4: All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, in conflict herewith are hereby repealed.
