AN ORDINANCE RELATING TO THE PROTECTION OF PEOPLE AND PROPERTY WITHIN THE BOUNDARIES OF CITY PARKS, RECREATION AREAS AND OTHER CITY FACILITIES; AMENDING TITLE 2, CHAPTER 9, SECTION 70, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, TO ESTABLISH THE PARK RANGER UNIT AS A DIVISION OF THE DEPARTMENT OF DETENTION AND CORRECTIONAL SERVICES; AMENDING TITLE 2, CHAPTER 28, SECTIONS 10 AND 20 OF SAID MUNICIPAL CODE TO REASSIGN THE PARK RANGER UNIT FROM THE DEPARTMENT OF PARKS, RECREATION AND SENIOR CITIZENS ACTIVITIES TO THE DEPARTMENT OF DETENTION AND CORRECTIONAL SERVICES; FURTHER AMENDING SAID SECTION 20 AND AMENDING SECTION 60 OF SAID TITLE AND CHAPTER TO EXPAND THE SCOPE OF AUTHORITY OF THE PARK RANGER UNIT TO INCLUDE AUTHORITY OVER ANY CITY FACILITY THAT IS DESIGNATED BY THE CITY MANAGER; REPEALING SECTION 90 OF SAID TITLE AND CHAPTER; AMENDING SECTION 110 OF SAID TITLE AND CHAPTER TO TRANSFER THE RESPONSIBILITY FOR TRAINING MEMBERS OF THE PARK RANGER UNIT FROM THE DEPARTMENT OF PERSONNEL AND EMPLOYEE RELATIONS TO THE DEPARTMENT OF DETENTION AND CORRECTIONAL SERVICES; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HERewith.

Summary: Reassigns Park Ranger Unit from Department of Parks, Recreation and Senior Citizens Activities to Department of Detention and Correctional Services and Expands the Unit's Scope of Authority.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 2, Chapter 9, Section 70, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

2.09.70: The Department of Detention and Correctional Services shall consist of the following divisions:

- (A) Support services;
- (B) Administrative records;
- (C) Rehabilitation programs[.];
- (D) Park Ranger Unit.

SECTION 2: Title 2, Chapter 28, Section 10, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

1 2.28.101: As used in this Chapter:

2 (A) "City Park Ranger Unit" means those persons employed
3 by the City as City Park Security Officers, who
4 comply with this Chapter and who are designated by
5 the Director of [Parks, Recreation and Senior
6 Citizen Activities] Detention and Correctional
7 Services as members of the City Park Ranger Unit.

8 (B) "City Park Security Officer" means any person
9 employed by the City to patrol the City parks [and
10 recreation areas and such other City facilities
11 as may be designated by the City Manager or his
12 designee, to protect people and property within
13 the boundaries [of any City park and recreation
14 area,] thereof and to perform other duties as
15 assigned. Such a person shall be known as a "Park
16 Ranger."

17 SECTION 3: Title 2, Chapter 28, Section 20, of the
18 Municipal Code of the City of Las Vegas, Nevada, 1983 Edition,
19 is hereby amended to read as follows:

20 2.28.02: There is established a City park Ranger Unit under the
21 Department of [Parks, Recreation and Senior Citizen
22 Activities.] Detention and Correctional Services. It
23 shall consist of those City Park Security Officers
24 who, complying with this Chapter are designated by the
25 Director of [Parks, Recreation and Senior Citizen
26 Activities] Detention and Correctional Services and
27 approved by the City Manager.

28 SECTION 4: Title 2, Chapter 28, Section 20, of the
29 Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is
30 hereby amended to read as follows:

31 2.28.60: While engaged in the actual performance of prescribed
32 duties, any City Park Ranger Unit member shall be

1 empowered to enforce all applicable State statutes,
2 City ordinances and City park regulations within the
3 boundaries of any City park or recreation [facility]
4 area or within any other City facility that may be
5 designated by the City Manager or his designee, and
6 within the immediate vicinity [thereof,] of any such
7 park, recreation area or facility, as the situation
8 warrants, when pursuing an individual who he has
9 reasonable cause to believe has committed a violation
10 in [a City] such park [or facility.], recreation area
11 or facility.

12 SECTION 5: Title 2, Chapter 28, Section 90, of the
13 Municipal Code of the City of Las Vegas, Nevada, 1983 Edition,
14 is hereby repealed in its entirety.

15 SECTION 6: Title 2, Chapter 28, Section 110, of the
16 Municipal Code of the City of Las Vegas, Nevada, 1983 Edition,
17 is hereby amended to read as follows:

18 2.28.110: Each City Park Security Officer shall complete a
19 City-approved training program as directed by the
20 Director of [Personnel and Employee Relations.]
21 Detention and Correctional Services.

22 SECTION 7: If any section, subsection, subdivision,
23 paragraph, sentence, clause or phrase in this ordinance or any
24 part thereof, is for any reason held to be unconstitutional or
25 invalid or ineffective by any court of competent jurisdiction,
26 such decision shall not affect the validity or effectiveness of
27 the remaining portions of this ordinance or any part thereof.
28 The City Council of the City of Las Vegas, Nevada, hereby declares
29 that it would have passed each section, subsection, subdivision,
30 paragraph, sentence, clause or phrase thereof, irrespective of
31 the fact that any one or more sections, subsections, subdivisions,
32 paragraphs, sentences, clauses or phrases be declared unconstitu-

1 tional, invalid or ineffective.

2 SECTION 8: All ordinances or parts of ordinances,
3 sections, subsections, phrases, sentences, clauses or paragraphs
4 contained in the Municipal Code of the City of Las Vegas, Nevada,
5 1983 Edition, in conflict herewith are hereby repealed.

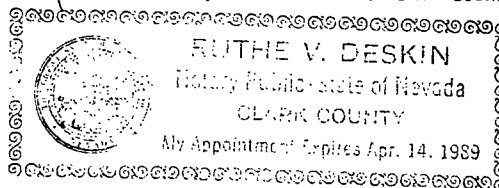
