ORDINANCE NO. 2000

AN ORDINANCE TO AMEND MAJOR STREET PLAN MAP ADOPTED BY ORDINANCE 1537 ON OCTOBER 6, 1971, INsofar AS IT RELATES TO PORTIONS OF Oakey Boulevard, Centennial Parkway, Desert Inn Road, Washburn Road, Jones Boulevard, Lorenzi Boulevard, Torrey Pines Drive, Washington Avenue, Tenaya Way, Gowan Road, Cheyenne Avenue, Westcliff Drive, Decatur Boulevard, Smoke Ranch Road, Craig Road, Vegas Drive, AND SAHARA AVENUE; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH.

Intent of Bill: To amend Major Street Plan Map adopted by Ordinance 1537 on October 6, 1971, insofar as it relates to portions of Oakey Boulevard, Centennial Parkway, Desert Inn Road, Washburn Road, Jones Boulevard, Lorenzi Boulevard, Torrey Pines Drive, Washington Avenue, Tenaya Way, Gowan Road, Cheyenne Avenue, Westcliff Drive, Decatur Boulevard, Smoke Ranch Road, Craig Road, Vegas Drive, and Sahara Avenue

THE BOARD OF CITY COMMISSIONERS OF THE CITY OF LAS VEGAS.

DOES ORDAIN AS FOLLOWS:

SECTION 1: The Major Street Plan of the City of Las Vegas, adopted by Ordinance No. 1537 on October 6, 1971, is hereby amended as follows:

- (A) Oakey Boulevard - from Las Vegas Boulevard South to East Fremont Street to be deleted.
- (B) CENTENNIAL PARKWAY - from Durango Drive to Rancho Drive and from Torrey Pines Drive to Decatur Boulevard reduced from 200 ft. to 100 ft.
- (C) DESERT INN ROAD - from Valley View Boulevard to Interstate 15 reduced from 100 ft. to 80 ft.
- (D) WASHBURN ROAD - from Tenaya Way to Torrey Pines Drive to be deleted.
- (E) JONES BOULEVARD - from Vegas Drive to Rancho Drive reduced from 100 ft. to 80 ft. and Engineering Drawing No. 115-364A.
- (F) LORENZI BOULEVARD - between the Las Vegas Expressway and Rancho Drive reduced from 100 ft. to 80 ft.
- (G) JONES BOULEVARD - from Del Rey Avenue to O'Bannon Drive add 100 ft. and from the centerline of Peak Drive to a point 1263.28 ft. north add 80 ft.

- (H) OAKEY BOULEVARD - from Torrey Pines Drive to Jones Boulevard add 80 ft.
- (I) TORREY PINES DRIVE - from Oakey Boulevard to O'Bannon Drive and from Vegas Drive to 660 ft. north of Vegas Drive add 80 ft.
- (J) WASHINGTON AVENUE - from Tenaya Way to the Rainbow Expressway add 80 ft.
- (K) TENAYA WAY - from Washington Avenue to Vegas Drive and from Cheyenne Avenue to 1014.38 ft. north of the Gowan Road centerline add 80 ft.
- (L) LORENZI BOULEVARD - from Cheyenne Avenue to 675.28 ft. north of the Gowan Road centerline add 80 ft.
- (M) GOWAN ROAD - from Tenaya Way to Lorenzi Boulevard add 80 ft.
- (N) CHEYENNE AVENUE - from Tenaya Way to Lorenzi Boulevard add 100 ft.
- (O) WESTCLIFF DRIVE - from Buffalo Drive to 1320.10 ft. west of Buffalo Drive add 100 ft.
- (P) DECATUR BOULEVARD - from Pennwood Avenue to 783.44 ft. south of Pennwood Avenue add 120 ft.
- (Q) SMOKE RANCH ROAD - from Decatur Boulevard to a point 290.41 ft. west of Decatur add 100 ft.
- (R) CRAIG ROAD - from Lorenzi Boulevard to the Rainbow Expressway add 150 ft.
- (S) VEGAS DRIVE - from Tenaya Way east a distance of 783.78 ft. add 80 ft.
- (T) SAHARA AVENUE - from Decatur Boulevard west a distance of 465.09 ft. add 100 ft.

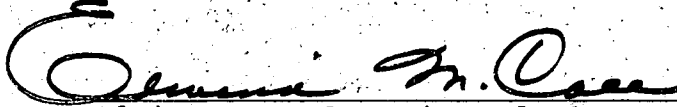
SECTION 2: All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

SECTION 3: If any section, paragraph, sentence, phrase, term, word or connotation of this ordinance or portion thereof, is for any reason held invalid, inapplicable, or unconstitutional by any Court of competent jurisdiction, such holding shall not invalidate the remaining portions of this ordinance.
