AN ORDINANCE RELATING TO THE SALE OF PISTOLS; AMENDING TITLE VI, CHAPTER 4, SECTION 5 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY EXPANDING THE CATEGORY OF BUSINESSES FROM WHICH APPLICATIONS FOR PISTOL PERMITS MAY BE ACCEPTED TO INCLUDE STORES WHICH OUTFIT AND EQUIP POLICE OFFICERS AND SECURITY GUARDS; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Provides for the issuance of pistol permits to stores which outfit and equip police officers and security guards.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title VI, Chapter 4, Section 5 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

6-4-5: Applications for pistol permits shall be accepted only from duly licensed hardware stores, gunsmith shops, sporting goods stores, stores which outfit and equip police officers and security guards, antique gun dealers and pawn shops where pistols may be sold or purchased in compliance with this Chapter.

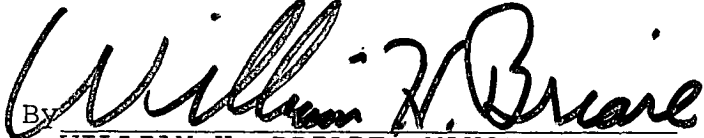
SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this Chapter or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this Chapter or any part thereof. The Board of City Commissioners of the City of Las Vegas, Nevada, hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections,

1 subdivisions, paragraphs, sentences, clauses or phrases be de-
2 clared unconstitutional, invalid or ineffective.

3 SECTION 3: All ordinances or parts of ordinances,
4 sections, subsections, phrases, sentences, clauses or paragraphs
5 contained in the Municipal Code of the City of Las Vegas,
6 Nevada, 1960 Edition, in conflict herewith are hereby repealed.

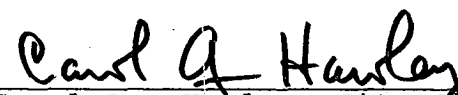
