2 **ORDINANCE NO. STRICKEN**

3 AN ORDINANCE TO REQUIRE PERSONS WHO WORK AS OUTCALL ENTERTAINERS TO
4 OBTAIN A HEALTH CARD, TO UNDERGO INITIAL AND PERIODIC MEDICAL
EXAMINATIONS, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Summary: Requires persons who work as
outcall entertainers to obtain a health card and to
undergo initial and periodic medical
examinations.

8 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
9 AS FOLLOWS:

10 SECTION 1: Title 6, Chapter 36, of the Municipal Code of the City of Las Vegas,
11 Nevada, 1983 Edition, is hereby amended to add the provisions set forth as Sections 2 and 3 of this
12 Ordinance.

13 SECTION 2: Each outcall entertainer shall maintain in force at all times a current
14 valid health card issued by the Clark County Health District. Before a health card is issued, and in
15 addition to any other requirements of the Clark County Health District, a medical examination is
16 required of all persons to be employed as outcall entertainers. In addition, outcall entertainers shall
17 undergo periodic medical examinations at least ____ a _____. Each such examination shall be
18 performed at no cost to the City or the Clark County Health District and shall:

19 (A) Be performed by or under the supervision of a physician duly licensed
20 to practice medicine in the State of Nevada;

21 (B) Be performed at the location of the licensed operation, at the physician's
22 office, or at a hospital or licensed clinic, as determined by the physician;

23 (C) Include tests approved by the Health Division of the Department of
24 Human Resources of the State of Nevada for the detection and diagnosis of sexually transmitted
25 disease, including without limitation tests for infectious syphilis, gonorrhea and chlamydia;

26 (D) Include tests approved by the Health Division of the Department of
27 Human Resources of the State of Nevada for the detection of Acquired Immune Deficiency Syndrome
28 (AIDS) and Human Immunodeficiency Virus (HIV); and

1 (E) Include other approved tests deemed advisable by the physician for the
2 detection of any infectious or contagious disease.

3 SECTION 3: The results of each test described in Section 2 shall be reported to the
4 Clark County Health District. If a health card applicant tests positive for AIDS, HIV or any other
5 sexually transmitted disease, a health card shall not issue. If an outcall entertainer who has been
6 issued a health card tests positive for AIDS, HIV or any other sexually transmitted disease, the health
7 card shall be revoked and the outcall entertainer's employment shall be terminated.

8 SECTION 4: If any section, subsection, subdivision, paragraph, sentence, clause or
9 phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid
10 or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
11 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
12 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
13 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
14 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
15 invalid or ineffective.

16 SECTION 5: Whenever in this ordinance any act is prohibited or is made or declared
17 to be unlawful or an offense or a misdemeanor, or whenever in this ordinance the doing of any act is
18 required or the failure to do any act is made or declared to be unlawful or an offense or a
19 misdemeanor, the doing of such prohibited act or the failure to do any such required act shall
20 constitute a misdemeanor and upon conviction thereof, shall be punished by a fine of not more than
21 \$1,000.00 or by imprisonment for a term of not more than six months, or by any combination of such
22 fine and imprisonment. Any day of any violation of this ordinance shall constitute a separate offense.

23 SECTION 6: All ordinances or parts of ordinances or sections, subsections, phrases,
